#### READING COMPREHENSION

Hence, the correct answer is option D.
- **Q2.** The correct answer is option **B.** In the given passage, the author has mentioned that the current battle is regarding identity and ideology while the previous battle was about culture. "Deep hostilities around educational curriculum and campus activism have made it clear that identity and ideology, the shaping forces behind the humanities, are looming larger than ever worldwide and, in fact, have started to play greater roles than the force of hard data and science in our bizarrely post-truth era."
- Q3. The correct answer is option B. The passage discusses the deep hostilities surrounding educational curriculum and campus activism, emphasizing the increasing influence of identity and ideology in the humanities. It highlights the role of these shaping forces in the humanities, asserting their prominence over hard data and science in the current post-truth era. Option A is not the correct answer because while the passage briefly mentions the takeover of means of persuasion and communication by AI, the primary focus is on identity, ideology, and humanities in education. The mention of AI is not central enough to warrant this title. Option C is not the correct answer because although the passage briefly references the culture wars in the US and the attacks on critical race theory, this is not the main focus. The broader discussion encompasses the influence of identity on education, making this option too specific.
- **Q4.** The correct answer is option **D.** In this question, rhetoric is a noun that means using language effectively to please or persuade. Rhetoric comes from the Greek meaning "speaker" and is used for the art of persuasive speaking or writing. When people listened eagerly to long speeches and studied them in school, rhetoric was generally used positively; now it is often a negative term, implying artfulness over real content
- **Q5.** The correct answer is option **D.** In the given passage the author has mentioned, "The legislative, pedagogic, and administrative in many parts of the US have now become unrelenting in their multi-pronged attack on critical race theory and on multiculturalist and decolonising projects in the humanities and the social sciences."

- **Q6.** The correct answer is option **A.** In the given passage, the author is critical of the 70 hour work week and another synonym for critical is being reproving. The tone is not sceptical because the author doesn't express doubt or disbelief in a neutral or questioning manner. Instead, the author takes a critical stance, expressing disapproval and raising concerns about the implications of a 70-hour work week. The language used suggests a negative judgment rather than a mere expression of doubt or uncertainty, aligning more with a reproving tone.
- **Q7.** The correct answer is option C. It is written in the passage, "Employees subjected to prolonged working hours often find themselves trapped in a cycle where the boundaries between professional and personal life blur, leaving little room for creative endeavours and rejuvenation."
- **Q8.** The correct answer is option **D.** The author touches upon all of the given topics in the passage in different paragraphs. Hence, the correct answer is option **D.** The passage is also a feminist critique of the 70-hour work-week as it talks about how it is possible if it occurs within the realm of 'male privilege." *Murthy's vision of a 70-hour work week also seems to be framed within the context of traditional male privilege.*" The author explains this in the third paragraph of the passage.
- **Q9.** The correct answer is option C. The author mentions "Murthy's exhortation echoes a perspective deeply rooted in privilege."
- Q10. The correct answer is option A. In this question, exhortation is a noun that means an earnest attempt at persuasion. Use an exhortation any time you really want to encourage someone to do something. It's a way of communicating that's persuasive and powerful an exhortation might come from a government in the form of a speech encouraging people to get flu shots, or it might be a teacher urging his students to sit quietly.
- Q11. The correct answer is option B. It is given in the passage, "To gain legitimacy, any global order needs to fulfil two conditions. First, a convergence among the major powers of the day, and, second, successfully presenting the outcome as a global public good to the rest of the world."

#### **CRITICAL REASONING**

**Q86. Option B is the correct answer**. The title "A Sky Full of Opportunities" best represents the passage as it highlights the optimism and potential for growth in India's aviation sector, as indicated by the record-breaking \$70-billion deal for Air India to purchase 470 planes from Airbus and Boeing. The passage discusses the significance of the purchase in modernizing Air India's fleet and helping it to expand its network, which is crucial for the country's booming aviation sector. While there are still challenges that need to be addressed, such as infrastructure and reforms, the passage focuses on the positive developments in the industry. Therefore, option B is the correct answer. The paragraph that supports this answer is the first and the last paragraph of the passage. Option A does not suffice as the title for the passage because the matter is not how Air India rose after collapse. Option C is too general. Also, whether it is dominance over West is not communicated in the passage. The deal is about bringing of India closer to the Western camp. Option D is written off, for the passage does not discuss the journey of Air India.

**Q87. Option A is the correct answer**. The passage mentions that the UK Prime Minister Rishi Sunak welcomed the Air India deal and specifically pointed out that Airbus will manufacture the wings in the UK. This is a subtle detail mentioned in the paragraph that shows the potential benefits of the deal for countries involved. The rest of the options have not been mentioned.

**Q88.** Option D is the correct answer. Because the author argues that Air India's purchase of hundreds of aircraft has geo-economic and geopolitical ramifications and enhances the image of corporate India, highlighting the India Story as "vibrant and interesting." Therefore, if the purchase of new aircraft does not represent a positive sign for India's economy, it would weaken the author's argument. The paragraph that justifies this answer is the last one, where the author calls for the government to prioritize infrastructure, such as airport expansion, and expedite reforms to ensure smaller towns have access to air travel. The author suggests that an imminent boom in the aviation sector is heartening, but this relies on improvements in infrastructure and reforms. Option A has been mentioned in the passage by the author, but with respect to congestions at the airports, but since the passage is about how the purchase will inform the world about the vibrant and interesting India Story, and the economic gains along with strategic placing of India globally, it does not weaken the fundamentals of the passage. Option B cannot weaken for it is a

future impact that cannot be taken as one of the options. Option C only strengthens the claims made in the

passage.

Q89. Option C is the correct answer. The author argues that the authorities must prioritize airport

expansion to ensure the success of the recent aircraft purchase by Indian carriers. This is mentioned in the

last paragraph of the passage, where the author states: "The first and foremost is infrastructure. Airport

expansion must be high on the priority list. Generally, our airports are crowded and badly managed."

Therefore, option C is the correct answer as it is the infrastructure challenge specifically mentioned by the

author in the passage. Option A and D are incorrect as they are not mentioned as infrastructure challenges

that the authorities must address. Option B is also incorrect as the author does not mention economic

reforms as a specific infrastructure challenge, but rather as a more general recommendation to expedite

reforms.

**Q90.** Option C is the correct answer. C is directly related to the topic of the passage, which is Air India's

recent purchase of 470 planes from Airbus and Boeing. The author mentions that this purchase will

modernize Air India's fleet and help it to dramatically expand its network, and that it is the largest purchase

by any carrier. Therefore, option C is the correct answer. Option A is irrelevant as it does not concern Air

India's aircraft purchase. Option B is also irrelevant, as fuel prices are not mentioned in the passage as a

factor in Air India's recent purchase. Option D is also irrelevant, as the passage does not discuss the impact

of Air India's purchase on the stock prices of Airbus and Boeing.

Q91. Option C is the correct answer. The correct answer is supported by the opening sentence of the

passage, which states that "The National Statistical Office's latest release of GDP data estimates a further

deceleration in growth in the October-December 2022 quarter." Option A is incorrect because the passage

discusses a deceleration in growth, not robust growth. Option B is incorrect because while the passage

mentions the need for policymakers to buttress domestic demand, it does not provide details about the

government's measures to boost the economy. Option D is incorrect because the passage notes that the

data revisions have made it harder, not easier, to draw meaningful conclusions.

Q92. Option D is the correct answer. The passage does not provide any information or suggestion about whether global demand is likely to recover in 2023. Option A is a valid inference as the passage mentions that contact-intensive sectors worst hit by the COVID-19 pandemic had begun to see a waning of pent-up demand. Option B is supported by the statement from the CEA that the revised year-earlier data affected the latest GDP estimates. Option C is a valid inference as the passage states that the mainstay private final consumption expenditure lost momentum during the traditional festival quarter when consumption spending usually peaks.

Q93. Option C is the correct answer. Policy makers should take measures to increase domestic demand to counter the weakening global demand. This option directly supports the author's argument that policy makers will need to do all they can to buttress domestic demand. The passage highlights that with global demand weakening considerably and unlikely to recover over the course of 2023, policy makers will need to take measures to strengthen domestic demand. Therefore, option C is the correct answer. Option A is incorrect as it suggests that increasing taxes would boost GDP growth, which is not supported by any information in the passage. Option B is incorrect as the passage does not suggest that the NSO data is unreliable, but rather that the data revisions have made it harder to draw meaningful conclusions. Option D is incorrect as the passage does not provide any evidence to suggest that the contraction in gross fixed capital formation is temporary and will recover soon.

Q94. Option B is the correct answer. The passage mentions that private final consumption expenditure lost momentum in the OctoberDecember 2022 quarter, and its percentage share of overall GDP eased to 61.6% from 63% in the year-earlier quarter. The passage further notes that this happened in the traditional festival quarter when consumption spending usually peaks, suggesting that the festival season did not lead to an increase in private consumption expenditure in the year-earlier quarter. Therefore, option B is correct. Option A is incorrect because the passage notes that manufacturing has contracted, not grown, although the rate of contraction has narrowed. Option C is incorrect because the passage states that global demand is weakening and unlikely to recover over the course of 2023. Option D is incorrect because the passage does not provide details about any policy solutions announced by the Indian government.

Q95. Option B is the correct answer. The passage states that "the mainstay private final consumption expenditure lost some momentum" and "suggests that the relentless pace of retail inflation is eroding consumptive capacity." This implies that the retail industry is experiencing a slowdown due to low consumer demand and rising inflation. Option A is incorrect because the passage does not suggest a surge in growth for the retail industry. Option C is incorrect because while policy makers are working to boost domestic demand, the passage does not provide evidence that this will have a significant impact on the retail industry in the short term. Option D is incorrect because the passage does provide information about the impact of the current economic situation on the retail industry.

Q96. Option C is the correct answer. Option A This option is incorrect because it only states a fact about the first-ever case of Chondrostereum purpureum infecting a human, but does not present the conclusion derived from the entire passage. Option B This option is incorrect because it focuses solely on the Kolkata case and does not consider the broader implications presented in the passage. Option C This option is correct because it summarizes the main argument of the passage by stating the expected increase in the threat of fungal infections due to climate change and growing resistance to treatments. It encompasses the key points made throughout the text. Option D This option is incorrect because, although it highlights the role of global warming in the spread of fungal infections, it does not provide the overall conclusion that fungal infections are expected to pose a greater threat to humans in the coming years.

Q97. Option D is the correct answer. Option A This option is incorrect because the argument does not rely on the assumption that the first-ever case of Chondrostereum purpureum infection represents a widespread trend in fungal infections. The argument is based on the broader implications of global warming and growing resistance to treatments. Option B This option is incorrect because, while the passage mentions that some fungi may exploit a natural selection, adaptation strategy, it is not a necessary assumption for the argument to hold. Option C This option is incorrect because the argument does not assume a direct proportionality between the increasing prevalence of fungal diseases and the rise in global temperatures. The argument focuses on the overall impact of rising temperatures on fungal infections. Option D This option is correct because the argument's conclusion about the expected increase in the threat

of fungal infections relies on the assumption that global warming will continue to cause a rise in temperatures. This will facilitate the spread and contact of thermotolerant fungal species with human populations, making the conclusion possible.

Q98. Option D is the correct answer. Option A is Incorrect - While the passage does highlight the dangers of the Chondrostereum purpureum infection and the possibility of future instances, it does not suggest that it will inevitably lead to a global pandemic like COVID-19. Option B is Incorrect - The passage does mention global warming as a significant factor in the emergence of this new threat, but it does not state that it is the sole cause of the Chondrostereum purpureum infection in humans. The text suggests that global warming could change the distribution of fungal species and facilitate their spread, but it does not imply that global warming is the only factor involved. Option C is Incorrect - The passage raises concerns that individuals with compromised immune systems may be particularly susceptible to such infections, as seen during the COVID-19 pandemic. However, it does not claim that the Chondrostereum purpureum infection will exclusively affect these individuals. Option D is Correct - The passage suggests that rising temperatures due to global warming and the adaptation of fungi may contribute to the increasing prevalence of fungal infections in humans. It discusses how global warming can change the distribution of heat-tolerant and susceptible fungal species and how some fungi may exploit a natural selectionadaptation strategy to adapt to higher temperatures.

Q99. Option B is the correct answer. Option A is Incorrect - The frequency of Chondrostereum purpureum infections in plants remaining constant does not address the link between rising global temperatures and the increasing prevalence of fungal infections in humans. It also does not provide any new information that would strengthen the argument. Option B is Correct - If the distribution of thermotolerant fungal species has expanded, leading to increased contact with human populations in warmer climates, it would strengthen the argument that rising global temperatures and fungi adaptation contribute to the increasing prevalence of fungal infections in humans. This new information demonstrates a direct connection between global warming and the spread of heat-tolerant fungi that can potentially infect humans. Option C is Incorrect - The development of a new antifungal medication specifically targeting Chondrostereum purpureum infections in humans does not address the link between rising global temperatures and the increasing prevalence of fungal infections. While it may help combat this specific

fungal infection, it does not strengthen the argument that global warming and fungi adaptation contribute to the overall increase in fungal infections in humans. Option D is Incorrect - The fact that the majority of people who have contracted secondary fungal infections have a history of exposure to plants in the rose family does not strengthen the argument that rising global temperatures and fungi adaptation are influencing the increasing prevalence of fungal infections in humans. It provides information about potential risk factors for contracting fungal infections, but it does not address the link between global warming and the spread of fungi.

This information will help to determine the direct relationship between global warming and the spread of fungi that can potentially infect humans. Option D is Incorrect - The increase in global temperatures and its relation to the prevalence of respiratory diseases other than fungal infections may provide context, but it does not directly address the influence of rising temperatures and fungi adaptation on the increasing prevalence of fungal infections in humans.

Q101. Option B is the correct answer. The article discusses the recent G20 meeting in Delhi and the challenges faced in achieving consensus, particularly with regards to the situation in Ukraine. However, it also highlights India's optimism and commitment to reforming multilateralism and addressing the challenges faced by the Global South. This is evident from the following statement in the passage: "India is right to remain optimistic and committed to a sustained effort to make the G20 summit in September a success." (last paragraph) Option A is partially correct but not the main focus of the article. Option C is a

true statement but not the main focus of the article. Option D is a specific detail mentioned in the article, but not the main focus.

Q102. Option B is the correct answer. The passage mentions that Russia has reinforced its defensive lines in Ukraine and is in the middle of a renewed military offensive. The passage also notes that Putin appears confident that time is on his side and a prolonged war would exhaust Ukraine, divide the West and allow Moscow to prevail, if at a massive cost to Russia. Therefore, it can be inferred that Russia is confident that a prolonged war in Ukraine will benefit Moscow in the long run. Option A is incorrect because the passage does not provide any information about the success of Russia's military offensive in Ukraine. Option C is incorrect because the passage states that Russia has successfully consolidated its strategic partnership with Beijing. Option D is incorrect because there is no information in the passage to suggest that Russia is interested in reaching a diplomatic agreement with Ukraine.

Q103. Option D is the correct answer. This option is similar to option A, but differs in that it focuses on the quantitative outcome alone. While the consequentialist X would choose to divert the trolley to save the lives of five people, their decision would not be based solely on the quantitative outcome, but rather on the overall benefit to society as a whole. Therefore, option A is a more appropriate answer for a consequentialist than option D.


