Answer: B

Reference Lines: "Terminating employment because the woman has got married is a coarse case of gender discrimination and inequality."

Difficulty Level: Moderate

Explanation: a) This option inaccurately confines the Court's perspective to legalistic interpretations, suggesting a narrow view that overlooks the Court's broader engagement with societal norms and values. The Supreme Court's decision, particularly its strong language against gender discrimination, indicates a deeper understanding and concern for societal impacts beyond mere legal technicalities. This misunderstanding of the Court's approach misses the holistic stance taken against gender biases. Hence, Option (a) is not the correct answer.

- b) By explicitly addressing and condemning the practice of terminating employment due to marriage, the Supreme Court demonstrates a clear commitment to challenging systemic gender biases. This decision not only addresses the specific case of Selina John but also sends a broader message that such discriminatory practices will not be tolerated, reflecting a proactive stance in promoting gender equality within the workforce and beyond. This understanding of the Court's actions aligns with the passage's emphasis on addressing and dismantling patriarchal norms that underpin discrimination. Hence, Option (b) is the correct answer.
- c) While the Court did award significant compensation to Selina John, suggesting recognition of the injustice she faced, to infer that the Court believes compensation alone can rectify gender discrimination oversimplifies its stance. The judgment goes beyond financial redress to address the underlying issues of gender bias and discrimination, aiming to set a precedent that discourages such practices in the future. This option fails to capture the broader implications of the Court's decision, which are aimed at systemic change rather than merely compensating for past injustices. Hence, Option (c) is not the correct answer.
- d) Suggesting that the Court's decisions are primarily influenced by international norms and standards rather than domestic law misrepresents the foundation of the Court's judgment. While international norms may inform the broader context within which the Court operates, its decisions are grounded in the Indian Constitution and legal framework, specifically the principles of equality and non-discrimination. This option overlooks the Court's role in interpreting and applying domestic law to combat gender discrimination within the specific cultural and legal context of India. Hence, Option (d) is not the correct answer.

2. Answer: B

Reference Lines: "Acceptance of such [a] patriarchal rule undermines human dignity, right to non-discrimination and fair treatment."

Difficulty Level: Moderate

Explanation: a) This option incorrectly suggests that the manifestation of gender biases is confined primarily to the realm of employment laws. The Supreme Court's decision to address the issue of employment termination due to marriage as unconstitutional goes beyond the specifics of employment law to challenge the underlying societal and patriarchal norms that enable such discrimination. This perspective is too narrow, failing to acknowledge the broader societal implications of the Court's observations. Hence, Option (a) is not the correct answer.

- b) This option correctly identifies the broader implication of the Supreme Court's decision, which extends beyond the immediate legal context to address the societal and cultural underpinnings of gender discrimination. By condemning the termination of women's employment due to marriage, the Court is highlighting and challenging the pervasive patriarchal norms that exist across both public and private sectors, affecting women's rights and opportunities. This understanding aligns with the passage's emphasis on the need to address and dismantle these broader societal norms. Hence, Option (b) is the correct answer.
- c) Suggesting that the Court implies legal actions alone are sufficient to combat gender inequality overlooks the complexity of the issue as presented in the passage. The Court's decision is an important step in challenging gender discrimination, but the broader discussion in the passage indicates that legal remedies must be part of a wider effort that includes societal change, education, and cultural shift. This option fails to capture the multifaceted approach needed to address gender inequality effectively. Hence, Option (c) is not the correct answer.



d) This option misinterprets the nature of gender discrimination as indicated by the Supreme Court's decision. The issue of gender discrimination, particularly in the context of employment due to marriage, is presented as part of a long-standing and deeply ingrained set of societal and cultural norms, not as a recent development. The passage and the Court's decision highlight the enduring nature of gender discrimination, challenging the notion that it is a recent phenomenon. Hence, Option (d) is not the correct answer.

Answer: C

Reference Lines: The entire passage discusses the Supreme Court's stance against gender discrimination, the ongoing struggle for gender equality in various sectors, and the implications for societal norms and practices.

Difficulty Level: Easy

Explanation: a) While highlighting the role of legal remedies in addressing gender discrimination, this title does not fully encompass the broader themes of the passage, which include the Supreme Court's role in catalyzing societal change beyond the courtroom. The passage discusses the implications of the Court's decisions within a larger context of societal norms and the struggle for gender equality, which extends beyond the immediate legal remedies. Hence, Option (a) is not the correct answer.

- b) Focusing on the economic impact of gender equality in the workplace, this title misses the broader narrative of the passage, which centers on the legal and societal challenges to gender discrimination and the need for a comprehensive approach to achieving gender equality. The passage emphasizes the Court's role in addressing these challenges, which involves more than just economic considerations. Hence, Option (b) is not the correct answer.
- c) This title accurately captures the essence of the passage, which not only discusses specific legal judgments by the Supreme Court but also the broader societal issues of gender discrimination and the need for change. It reflects the interconnectedness of legal decisions and the broader societal implications, highlighting the role of the judiciary in bridging the gap between legal judgments and societal change towards gender equality. Hence, Option (c) is the correct answer.
- d) By focusing solely on a legal analysis of gender discrimination, this title fails to capture the passage's broader scope, which includes the societal and cultural dimensions of the struggle for gender equality. The passage examines the implications of the Supreme Court's decisions within a wider context of changing societal norms and the ongoing effort to achieve gender equality. Hence, Option (d) is not the correct answer.

Difficulty Level: Moderate

This misunderstanding overlooks the decision's potential to inspire further legal and societal changes. Hence, Option (a) is not the correct answer.

- b) This option accurately captures the essence of the passage, which presents the Supreme Court's decision as a landmark moment in the fight against gender discrimination and patriarchal oppression in the workplace. By emphasizing the unconstitutionality of penalizing women for marriage, the Court challenges longstanding gender biases and advocates for a more inclusive and equitable work environment. This interpretation aligns with the passage's discussion of broader implications for gender equality. Hence, Option (b) is the correct answer.
- c) While the Supreme Court ordered financial compensation, the passage emphasizes that the ruling's significance extends far beyond the monetary aspects. It addresses systemic issues of gender discrimination and seeks to challenge and change patriarchal norms in the workplace. Focusing solely on compensation misses the broader context of the ruling as a step towards gender equality. Hence, Option (c) is not the correct answer.



d) This option misrepresents the passage, which critiques rather than endorses traditional patriarchal roles and norms. The Supreme Court's decision is framed as progressive, challenging outdated and discriminatory practices, not supporting them. Suggesting that the ruling upholds traditional roles contradicts the passage's portrayal of the decision as advancing gender equality. Hence, Option (d) is not the correct answer.

Answer: C

Reference Lines: The passage provides insights into the issues of gender discrimination and the Supreme Court's actions against such practices, particularly in the context of employment and societal norms.

Difficulty Level: Moderate

Explanation: a) This option, while partly accurate, narrowly frames the passage as only an examination of the legal system's responsiveness. It overlooks the broader thematic concerns of gender discrimination in the workplace and the societal implications discussed throughout the passage. The focus is not only on the legal system but also on the need for societal change. Hence, Option (a) is not the correct answer.

- b) This option misinterprets the passage's focus, suggesting a critique of the legal system's overall failures. While the passage does address gender disparities, it specifically highlights the Supreme Court's successful intervention as a positive step toward addressing these issues, rather than pointing out failures. Hence, Option (b) is not the correct answer.
- c) This option provides a comprehensive summary that captures the essence of the passage. It acknowledges the pervasive issue of gender discrimination in the workplace and highlights the Supreme Court's active role in challenging these practices, reflecting the passage's emphasis on legal and societal efforts towards gender equality. Hence, Option (c) is the correct answer.
- d) Focusing on Selina John's legal battle and the financial compensation aspect, this option fails to capture the passage's broader discussion on gender discrimination, the Supreme Court's stance, and the implications for societal norms and workplace practices. The passage is not limited to the financial aspects but addresses systemic change. Hence, Option (d) is not the correct answer.

6. Answer: C

Difficulty Level: Easy

Explanation: a) This option is the opposite of the Supreme Court's actual stance. Suggesting endorsement contradicts the Court's actions and the passage's portrayal of these actions. Hence, Option (a) is not the correct answer.

- b) Ambivalence suggests a lack of clear stance or a feeling of uncertainty, which does not align with the Supreme Court's decisive and clear condemnation of gender discrimination. The passage portrays the Court as taking a strong, unambiguous position against such practices. Hence, Option (b) is not the correct answer.
- c) This option accurately reflects the Supreme Court's stance as described in the passage. The Court's critical observations and the decision to award compensation demonstrate a clear condemnation of discriminatory rules against women, particularly those penalizing marriage. This term aligns with the passage's depiction of the Court's efforts to combat gender discrimination. Hence, Option (c) is the correct answer.
- d) Indifference implies a lack of interest or concern, which is contrary to the active and engaged stance taken by the Supreme Court. The passage details the Court's proactive and concerned approach to addressing and rectifying instances of gender discrimination. Hence, Option (d) is not the correct answer.

7. Answer: B

Difficulty Level: Moderate

Explanation: a) This option inaccurately suggests a passive and undisturbed early universe, directly contradicting the described characteristics of J0529-4351, which highlight a period of significant energy



and activity. The discovery of such a massive and bright accretion disc around a black hole implies a universe far more dynamic and tumultuous than one characterized by calmness and minimal occurrences. Hence, Option (a) is not the correct answer.

- b) Reflecting the passage's details, this option correctly suggests that the early universe was a place of considerable activity, where supermassive black holes played a pivotal role in shaping cosmic evolution. The specific mention of J0529-4351's accretion disc's brightness and size underscores an era of intense gravitational interactions and material consumption by black holes, marking a universe alive with dramatic astronomical events. Hence, Option (b) is the correct answer.
- c) Introducing an idea of civilizations influencing galactic formations adds an element of speculation not supported by the passage. The text focuses on natural astronomical phenomena to explain the conditions of the early universe, without delving into the potential actions of civilizations. This option distracts from the scientific observations and theories presented in the passage. Hence, Option (c) is not the correct answer.
- d) Misrepresents the evidence provided by the discovery of J0529-4351. The passage suggests that early black holes, such as J0529-4351, were not only larger but also more active than many observed in the current universe, contrary to the implication that they were smaller and exhibited less activity. This misunderstanding overlooks the passage's emphasis on the significant role and presence of supermassive black holes in the early universe. Hence, Option (d) is not the correct answer.

Answer: D

Reference Lines: "The age of the black hole feeding frenzy is over because the gas floating around in galaxies has mostly been turned into stars."

Difficulty Level: Easy

Explanation: a) While the discovery certainly expands our understanding of black holes, the central theme of the passage goes beyond just revising beliefs about their growth and size. It touches upon the broader narrative of how the universe has transitioned from a state of intense activity, as exemplified by J0529-4351, to its current more stable state. This option, therefore, narrows the scope of the passage's main message. Hence, Option (a) is not the correct answer.

- b) This option misses the core message of the passage. The text aims to contrast the turbulent past of the universe, marked by active black hole accretion, with the relative calm of the present era, rather than simply noting the peaceful coexistence of black holes and stars today. It does not capture the evolutionary aspect that is central to the passage. Hence, Option (b) is not the correct answer.
- c) Focuses on an aspect (technological challenges) that, while important, is not discussed in the passage. The main thrust of the text is on the implications of J0529-4351's discovery for our understanding of cosmic history, not on the observational challenges astronomers face. This option diverts attention away from the passage's discussion of the universe's evolution. Hence, Option (c) is not the correct answer.
- d) Accurately encapsulates the passage's overarching narrative, which is the transition of the universe from an era of significant black hole activity, symbolized by the discovery of J0529-4351, to a more structured and orderly cosmic environment. This option directly aligns with the information and theme presented, making it the most representative summary of the passage's central idea. Hence, Option (d) is the correct answer.

9. Answer: D

Reference Lines: "Astronomers will continue to explore the early universe's conditions, using supermassive black holes as key windows into cosmic history and evolution."

Difficulty Level: Moderate

Explanation: a) Incorrectly assumes a decline in interest in black hole research, which contradicts the passage's implications that supermassive black holes remain a focal point for understanding the universe's early conditions and overall evolution. This option overlooks the significance of discoveries like J0529-4351 in providing insights into cosmic history. Hence, Option (a) is not the correct answer.

- b) While future research may indeed involve seeking out larger and more luminous black holes, this option narrowly focuses on the quest for extremes rather than the broader scientific goal of understanding the universe's past. The passage suggests that the study of black holes like J0529-4351 is crucial for insights into the early universe, not just for finding bigger objects. Hence, Option (b) is not the correct answer.
- c) Misleads by suggesting a shift in research focus away from black holes, contrary to the passage's emphasis on their continued importance in cosmic studies. Supermassive black holes are presented as



crucial for understanding the universe's evolution, not as a diminishing area of interest. Hence, Option (c) is not the correct answer.

d) Correctly infers from the passage that the study of supermassive black holes, especially those with significant accretion discs like J0529-4351, will remain essential for exploring the universe's early conditions and understanding its evolution. This option aligns with the narrative that black holes provide invaluable insights into the cosmic past, highlighting their role in future astronomical research. Hence, Option (d) is the correct answer.

Answer: B

Reference Lines: "The accretion disc of J0529-4351 emits light that is 500 trillion times more intense than that of our Sun."

Difficulty Level: Moderate

Explanation: a) This option misinterprets the passage. The description of J0529-4351 contradicts the idea of black holes being primarily dormant. The passage focuses on the active nature of this particular black hole, indicating a period of significant growth and energy release. Hence, Option (a) is not the correct answer.

- b) Correctly captures the essence of the discovery. The immense brightness and mass of J0529-4351's accretion disc suggest that supermassive black holes underwent phases of aggressive material consumption and high activity levels, challenging previous notions of their behavior. This aligns with the passage's depiction of J0529-4351, emphasizing its role in reshaping our understanding. Hence, Option (b) is the correct answer.
- c) Incorrect, as the discovery of J0529-4351 indicates a dynamic evolutionary process for black holes, from highly active states to more dormant phases in the current universe. The passage describes a transition in black hole activity over time, not a consistency in behavior. Hence, Option (c) is not the correct answer.
- d) While this option touches on the idea of growth, it does not fully encapsulate the significant implications of J0529-4351's discovery regarding the active consumption and accumulation of material by supermassive black holes in the early universe. The key aspect of intense activity is not as emphasized as in Option B. Hence, Option (d) is not the correct answer.

11. Answer: B

Difficulty Level: Easy

Explanation: a) Incorrect because the passage does not employ "like" or "as" in its comparison, which is essential for a simile. The direct comparison without these words indicates a different figure of speech is at play, making this option inaccurate. Hence, Option (a) is not the correct answer.

- b) Correct as it identifies the usage of a metaphor in the passage. The text makes a direct comparison between J0529-4351's conditions and Hell, suggesting extreme conditions without the use of "like" or "as," fitting the definition of a metaphor. Hence, Option (b) is the correct answer.
- c) Incorrect because personification involves giving human characteristics to non-human entities, and the passage does not suggest that the black hole possesses human-like qualities or behaviors. The comparison made is about the conditions, not attributing human traits. Hence, Option (c) is not the correct answer.
- d) This option is not accurate because the passage uses the comparison to Hell to convey the severity of conditions around J0529-4351, not necessarily to exaggerate but to highlight its extreme nature. The figure of speech used aims more to compare than exaggerate. Hence, Option (d) is not the correct answer.

12. Answer: B

Reference Lines: "The disc is heated by friction as the material in it rubs together."

Difficulty Level: Easy

Explanation: a) This option is not correct because it suggests an inaccurate portrayal of the accretion disc. The passage describes the accretion disc as a highly active area, where material is intensely heated due to friction, leading to significant brightness, indicating a dynamic and not a stable structure. Hence, Option (a) is not the correct answer.



- b) Correct as it precisely reflects the passage's description of the accretion disc around J0529-4351. The disc's intense friction and resulting brightness highlight its dynamic nature and crucial role in the black hole's growth and energy emission. This aligns with the detailed explanation provided in the text. Hence, Option (b) is the correct answer.
- c) Incorrect because the passage explains the accretion disc as a region where material is accumulated before being consumed by the black hole, rather than acting as a barrier. The disc facilitates the process of material moving towards the black hole, not preventing it. Hence, Option (c) is not the correct answer.
- d) This option is not correct as the passage discusses the accretion disc of J0529-4351 as an observable and significant feature, not as a purely theoretical concept. The detailed observations and implications for our understanding of black holes confirm its observed nature. Hence, Option (d) is not the correct answer.

13. Answer: C

Reference Lines: "The job market is transforming, with new careers emerging as automation and artificial intelligence (AI) advances."

Difficulty Level: Moderate

Explanation: a) This option misrepresents the passage's message. The passage clearly indicates that the advent of technology and digitalization has dramatically transformed job markets, making some traditional skills obsolete and creating a need for professionals to learn new, relevant skills. There is no indication that technology has stabilized job markets in the sense of keeping traditional skills relevant. Hence, Option (a) is not the correct answer.

- b) Incorrect as the passage explicitly states that online booking systems and user-friendly publishing software have reduced the demand for travel agents and desktop publishers, respectively. This suggests that technology has not enhanced these roles but rather made them less necessary, highlighting the displacement of certain job functions by technological solutions. Hence, Option (b) is not the correct answer.
- c) Correctly captures the essence of the passage, which emphasizes the transformative impact of technological progress on the job market. It points out that professionals must continually update their skills to remain competitive and adapt to changes brought about by automation, AI, and other technological advancements. This continuous skill development is essential for navigating the evolving landscape of the job market. Hence, Option (c) is the correct answer.
- d) This option is contrary to the passage's content, which suggests that building a personal brand has become increasingly important in the modern job market. Personal branding, enriched through online education and skill development, helps individuals stand out and access better opportunities, underscoring its growing importance rather than diminishment. Hence, Option (d) is not the correct answer.

14. Answer: B

Reference Lines: "The COVID-19 pandemic has thrown this trend into overdrive. It has highlighted the need for workers and employers to be flexible to adjust to remote work, evolving job demands and uncertain prospects."

Difficulty Level: Moderate

Explanation: a) This option inaccurately reflects the passage's content, which suggests the pandemic has accelerated the shift towards more flexible and independent work modalities, such as freelancing. The trend indicates an increased interest in freelancing due to its inherent flexibility and autonomy, contrasting with the idea of a shift back to more traditional, stable employment. Therefore, this interpretation is at odds with the passage's discussion of changing work dynamics in the context of the pandemic. Hence, Option (a) is not the correct answer.

- b) This option is accurate and aligns with the passage's narrative. The COVID-19 pandemic has indeed amplified the significance of achieving a satisfactory work/life balance and the need for career flexibility in the face of rapidly changing global and professional landscapes. This shift reflects a broader reevaluation among workers of what they value in their careers, underscoring the desire for roles that offer adaptability and a better alignment with personal life and goals. The passage explicitly mentions these evolving preferences as a response to the pandemic, making this the correct answer. Hence, Option (b) is the correct answer.
- c) Contrary to the passage's implications, this option suggests a regression to more traditional career trajectories, which is not supported by the text. The passage clearly indicates a movement towards greater



career fluidity and the exploration of diverse industries and roles, driven by technological advancements and altered work environments due to the pandemic. This misinterpretation overlooks the emphasis on adaptability and exploration in response to changing economic and social conditions. Hence, Option (c) is not the correct answer.

d) This option misrepresents the passage, which notes an increased, not reduced, emphasis on the need for flexibility and the capability for remote work as critical factors in job preferences post-pandemic. The pandemic has highlighted the importance of these aspects due to shifting work conditions and the necessity of adapting to new modes of operation, including remote work arrangements. This discrepancy suggests a misunderstanding of the passage's discussion on how the pandemic has reshaped priorities and expectations in the workforce. Hence, Option (d) is not the correct answer.

15. Answer: C

Reference Lines: "Jobs can be widely publicised and explored online and are no longer tied to your city of birth. Add to this the rapid technological progress."

Difficulty Level: Moderate

Explanation: a) This option misunderstands the passage's message. Rather than reducing the value of traditional jobs and enforcing rigidity, globalization and technological progress have expanded job opportunities, necessitating a more adaptable and flexible approach to career development. The passage emphasizes the diversification of career paths enabled by these factors, contrary to suggesting an imposition of more rigid structures. Hence, Option (a) is not the correct answer.

- b) Incorrect, as the passage illustrates that the pandemic has not reversed but accelerated trends towards digital accessibility and remote work. It points to an adaptation to and an embrace of these trends, highlighting the increased importance of flexibility and the ability to work remotely, in contrast to advocating for a return to traditional job roles. Hence, Option (b) is not the correct answer.
- c) Accurately encapsulates the essence of the passage. It reflects the passage's discussion on how globalization, technological advancements, and the COVID-19 pandemic have collectively transformed the job market. This transformation demands continuous skill development and adaptability from professionals to navigate the challenges and opportunities presented by these changes effectively. The summary captures the dynamic nature of the current job market, influenced significantly by technological progress and the pandemic's impact. Hence, Option (c) is the correct answer.
- d) This option is not supported by the passage, which suggests a job market that is becoming increasingly dynamic, with an emphasis on skill development, personal branding, and adaptability. There is no indication that an employer's focus on loyalty is leading to a static job market; rather, the text discusses how employees might seek opportunities elsewhere if their skills are underutilized, indicating a market that values flexibility and continuous learning. Hence, Option (d) is not the correct answer.

16. Answer: C

Reference Lines: "As a result, career paths have become fluid and multi-directional."

Difficulty Level: Easy

Explanation: a) This option contradicts the passage's message. The term "fluid and multi-directional" suggests adaptability and openness to change, not rigidity or predictability. The passage emphasizes the evolving nature of career paths away from traditional linear trajectories, making this choice incorrect. Hence, Option (a) is not the correct answer.

- b) Incorrect, as the passage suggests the opposite. The "fluid and multi-directional" nature of career paths highlights a move away from early career specialization towards embracing a broader range of experiences and roles. It indicates a shift towards versatility and adaptability in professional life. Hence, Option (b) is not the correct answer.
- c) Correct, because it captures the essence of what the passage conveys about the changing nature of career paths. The description of careers as "fluid and multi-directional" points to the increased flexibility in professional life, allowing individuals to explore different paths, switch industries, and adapt to new opportunities. This reflects a significant shift from the traditional, more linear career progression. Hence, Option (c) is the correct answer.
- d) This option is misleading. The passage's discussion of fluid and multi-directional career paths implies a need for ongoing professional development to navigate the changes successfully. It suggests that



continuous learning and skill adaptation are crucial, contrary to the idea that professional development is no longer necessary. Hence, Option (d) is not the correct answer.

17. Answer: B

Reference Lines: "Globalisation has turned the world economy into a giant, interconnected web."

Difficulty Level: Moderate

Explanation: a) Incorrect because the passage clearly states that globalization has expanded the job market beyond local boundaries, making it a vast, interconnected web. This expansion contradicts the notion of limiting opportunities to local markets only. Hence, Option (a) is not the correct answer.

- b) Correct, as it directly aligns with the passage's description of globalization's effects. By turning the world economy into an interconnected web, globalization has intensified competition in the job market and made talent and opportunities more diverse and digitally accessible, breaking down geographical barriers to employment. Hence, Option (b) is the correct answer.
- c) This option misinterprets the passage, which highlights the increase in diversity and accessibility of talent due to globalization. The passage suggests that globalization has broadened, not decreased, the pool of talent and opportunities available. Hence, Option (c) is not the correct answer.
- d) Incorrect, as the passage emphasizes the role of digital accessibility and the global nature of job opportunities, suggesting a move towards more modern, digital forms of employment rather than a return to traditional ones. Globalization is portrayed as a driver of change towards digital and remote work environments. Hence, Option (d) is not the correct answer.

Hence, Option (c) is not the correct answer.
- d) Incorrect as "overpopulation" is not used adverbially in the passage. Adverbs modify verbs, adjectives, or other adverbs, but the term in question acts as the subject of discourse, identifying a specific demographic and ecological issue, rather than modifying how an action is performed. Hence, Option (d) is not the correct answer.

As per the author, the waste pickers face "systemic marginalization due to *non-recognition*". Hence, Option (a) is not the correct answer.

- b) Private sector efficiency and sustainability gains do not detrimentally affect informal waste pickers. This option directly contradicts the passage's message that the involvement of the private sector in waste management, often under the guise of efficiency and sustainability, tends to exclude and negatively impact informal waste pickers. The passage likely critiques this perspective by highlighting the adverse effects on informal waste pickers, such as job loss, reduced access to recyclables, and increased vulnerability. Therefore, this is the statement the author is most likely to disagree with, making Option (b) the correct answer.
- c) Informal waste pickers, excluded from formal systems, endure health risks and social marginalisation. The passage discusses the waste pickers' "health risks" by mentioning that their "health issues include dermatological and respiratory health issues apart from regular injuries". Further, the author discusses



social "marginalization" of the waste pickers when he says "they face systemic marginalisation" and that they have a "subordinate position in the caste hierarchy". Hence, Option (c) is not the correct answer.

d) Formal waste management integration could elevate informal waste pickers' economic and social standing. Although not specifically stated, This option suggests a solution or positive outcome that the passage likely advocates for. Integrating informal waste pickers into formal waste management processes could provide them with legal recognition, stable income, and improved working conditions, thereby addressing some of the core issues of marginalisation and vulnerability they face. The passage likely supports this view as a means to enhance both the efficiency of waste management and the well-being of informal waste pickers. Hence, Option (d) is not the correct answer.

86. Answer: A

Reference Line: "Private sectors employ expensive machinery, offering competitive rates to waste generators such as households and businesses, which marginalises informal pickers."

Difficulty Level: Moderate

By securing contracts, these cooperatives can ensure a steady income for waste pickers and affirm their legal rights to collect waste, challenging the dominance of private companies and their competitive pricing strategies. This move could potentially shift the balance of power and resources towards informal waste pickers, undermining the private sector's ability to marginalize them. Hence, Option (a) is the correct answer.

- b) Private sector's recycling cost reductions enhance profitability across the board due to technological innovations. While this option might seem beneficial for the waste management industry as a whole, it does not directly address the issue of competitive rates undermining the position of informal waste pickers. Technological advancements leading to cost reductions could further empower private companies, potentially increasing their market share and influence without necessarily improving the situation for informal waste pickers. This option does not undermine the effectiveness of competitive rates in marginalizing informal pickers but rather could exacerbate the issue. Hence, Option (b) is not the correct answer.
- c) Non-governmental organizations equip most informal waste pickers with health insurance and safety gear. Providing health insurance and safety gear is undoubtedly beneficial for the well-being of informal waste pickers. However, this option does not directly challenge the private sector's competitive rates or their impact on the marginalization of informal waste pickers. While improving health and safety conditions is crucial, it does not address the economic dynamics and competitive pressures brought by the private sector that undercut informal waste pickers' livelihoods. Hence, Option (c) is not the correct answer.
- d) Private companies now exclusively hire informal waste pickers, offering them social security and stable salaries. This option presents a scenario where private companies integrate informal waste pickers into their operations, potentially improving their working conditions and economic stability. While it suggests a form of inclusion, it does not inherently undermine the competitive rates' impact on the broader informal waste picking community. The core issue is the systemic marginalization and exclusion from waste materials caused by competitive pricing strategies, not just employment status. Hence, Option (d) is not the correct answer.

Option C is incorrect because while providing safety equipment and training would benefit waste pickers, it doesn't address the broader issues of social security, legal protection, and systemic marginalization discussed in the passage.

Option D is incorrect because while legislation mandating profit allocation sounds promising, it doesn't directly address the systemic issues faced by waste pickers nor does it ensure their inclusion in social security schemes and legal protection frameworks as advocated in the passage.

By doing so, it not only acknowledges their crucial role but also actively works to reduce their marginalization through formal recognition and integration. This approach could lead to improved working conditions, legal rights, and social recognition for informal waste pickers, effectively bridging the gap between their importance and their current marginalized status. Hence, Option (b) is the correct answer.
- c) Technology advancements allowing for the complete automation of waste collection, eliminating the need for manual labor. While technological advancements could streamline waste collection processes, this option does not resolve the paradox of the crucial yet marginalized role of informal waste pickers. Instead, it could potentially exacerbate their marginalization by rendering their labor obsolete without addressing the systemic issues of social and economic inclusion. The passage likely advocates for solutions that integrate and value human contributions rather than replacing them with technology. Hence, Option (c) is not the correct answer.
- d) Private waste management companies increasing their service fees to cover the cost of integrating informal waste pickers. This option suggests a financial strategy for integrating informal waste pickers, but it does not directly resolve the paradox. Increasing service fees might provide the means for including informal waste pickers, but it does not guarantee their integration or address the systemic barriers to their inclusion. The core issue is not just financial but involves legal, social, and operational changes to ensure that informal waste pickers are recognized and valued within the waste management ecosystem. Hence, Option (d) is not the correct answer.

Difficulty level: Moderate

- C) While the passage mentions the economic aspect of waste picking, it does not primarily analyze its impact on urban populations globally. Therefore, option C is incorrect.
- D) While the passage mentions the need for government regulation to protect waste pickers' rights and safety, this is not the main purpose of the passage. The primary focus is on highlighting the challenges faced by waste pickers. Therefore, option D is incorrect.

Technology might mitigate some physical risks but without addressing the systemic issues, the overall working conditions of waste pickers may not significantly improve. Hence, Option (c) is not the correct answer.

This option could provide more stable income opportunities for informal waste pickers by linking them directly with private companies. However, without adequate safeguards, it may not guarantee improved working conditions or address issues such as health benefits, safety training, or social recognition. While potentially beneficial, it lacks the direct and comprehensive approach to improving working conditions outlined in option (b). Hence, Option (d) is not the correct answer.

- b) We have no basis of challenging the fact that the passage's sweeping claim that no ecosystem is untouched by invasive species overlooks the existence of isolated or minimally impacted ecosystems. For all we know, the author may have done their research. This critique does not identify a flaw in "reasoning" and merely challenges the fact that there are might be untouched or less affected areas, which could provide counterexamples to the claim of "universal" impact. The universality is not the central claim, the "deep and pervasive" impact is, Hence, Option (b) is an incorrect answer.
- c) This option suggests that the passage's exclusive focus on human-driven spread overlooks the role of natural species migration. While natural migrations do occur and can contribute to the spread of invasive species, the passage specifically emphasizes the accelerated spread due to human actions, which is a distinct and significant factor in the context of invasive species proliferation. This critique misdirects from the passage's focus on the amplifying effect of human activities, thus not effectively revealing a flaw in the passage's reasoning. Hence, Option (c) is not the correct answer.
- d) Suggesting that the passage's emphasis on invasive species as a major change driver could diminish the perceived importance of climate change and pollution is an interesting critique. However, the passage likely presents invasive species as one of several significant factors affecting biodiversity and ecosystem health, not in isolation from other environmental threats. This option misinterprets the passage's intent, which is to highlight the significance of invasive species without necessarily ranking it above other environmental challenges. Hence, Option (d) is not the correct answer.

105. Answer: A

Difficulty Level: Moderate

Explanation: a) This option accurately captures an underlying assumption of the passage—that there is still time and means to effectively address the issue of invasive species through global cooperation and action. The passage's urgent tone and call for action imply a belief in the potential for mitigation and reversal of the negative impacts of invasive species if there is a swift and comprehensive response. This reflects an optimistic view on the efficacy of global efforts, aligning with the passage's call to action. Hence, Option (a) is the correct answer.

- b) Contrary to asserting that current measures are sufficient, the passage's urgent tone and call for increased action suggest that existing efforts to combat the spread and impact of invasive species are deemed inadequate. This option misinterprets the passage's message, which implicitly calls for more robust global measures rather than expressing satisfaction with current efforts. The assumption here is not about the adequacy of current measures but about the potential effectiveness of enhanced global action. Hence, Option (b) is not the correct answer.
- c) Suggesting that the passage views the proliferation of invasive species as unstoppable and beyond human intervention misreads the urgency and intent of the call to action. The passage likely emphasises the significant role of human activity in the spread of invasive species and suggests that human efforts can also play a crucial role in mitigating this issue. This option presents a fatalistic interpretation that contradicts the passage's underlying assumption of the possibility for effective intervention. Hence, Option (c) is not the correct answer.
- d) By implying that the passage assumes global awareness and educational efforts are already widespread, this option overlooks the passage's likely emphasis on the need for increased awareness and action. The call for urgent and comprehensive global action suggests an acknowledgment that current levels of awareness and effort are insufficient, indicating an assumption that more needs to be done to educate and mobilize global responses. Hence, Option (d) is not the correct answer.

Difficulty Level: Moderate

Instead, it suggests a counterpoint that some ecosystems may not be as severely affected, potentially undermining the argument's urgency and scale. This option, therefore, does not support the argument but rather introduces a mitigating perspective on the impacts of invasive species. Hence, Option (a) is not the correct answer.

- b) This option directly supports the argument by providing empirical evidence of the severe consequences of invasive species on biodiversity. By stating that invasive species are leading to the extinction of native species at an unprecedented rate, it underscores the profound and escalating nature of the threat they pose. This aligns with the passage's claim about the significant impact of invasive species, reinforcing the argument with concrete evidence of their detrimental effects on global biodiversity. Hence, Option (b) is the correct answer.
- c) While successful control efforts are positive and indicate potential for mitigating the impacts of invasive species, this option does not directly support the argument about the overall profound and escalating threat. It highlights localized successes rather than addressing the global scale and increasing trend of invasive species' impact on biodiversity. This does not strengthen the argument but instead points to the effectiveness of management strategies in specific contexts. Hence, Option (c) is not the correct answer.
- d) Comparing threats to biodiversity introduces a different argument about the relative significance of various environmental challenges. By suggesting that climate change is a more significant threat, this option shifts focus away from the specific issue at hand—the impact of invasive species. While important, this comparison does not strengthen the argument regarding the profound and escalating impact of invasive species on global biodiversity but rather diverts attention to another environmental concern. Hence, Option (d) is not the correct answer.

107. Answer: D

Reference Lines: "Invasive alien species are a major threat to biodiversity and can cause irreversible damage to nature."

Difficulty Level: Moderate

Explanation: a) The development of effective methods for removing invasive species is a positive step toward mitigating their impact. However, this option does not directly address the argument about the irreversible nature of the damage caused by invasive species. While it suggests potential for remediation, it does not fundamentally challenge the claim of irreversible damage, as the existence of removal methods does not guarantee the restoration of ecosystems to their original states. Hence, Option (a) is not the correct answer.

- b) A reduction in new introductions of invasive species is beneficial for biodiversity conservation. However, this option does not directly weaken the argument about irreversible damage already caused by existing invasive species. The focus on prevention of future introductions does not address the consequences of invasions that have already occurred and their claimed irreversible impacts on ecosystems. Hence, Option (b) is not the correct answer.
- c) Enhancing international trade regulations to prevent the spread of invasive species addresses a significant pathway for their movement. While this is a crucial preventive measure, it does not directly counter the argument about the irreversible damage caused by invasive species that are already established. This option focuses on prevention rather than the reversibility of existing impacts, which is central to the argument being challenged. Hence, Option (c) is not the correct answer.
- d) This option provides a direct counterpoint to the argument about irreversible damage by suggesting that invasive species can integrate into ecosystems in a way that does not harm biodiversity. If many invasive species fill ecological niches without displacing native species, it challenges the premise that their impact is universally negative and irreversible. This undermines the argument by indicating that the ecological dynamics involving invasive species can be more complex and not necessarily detrimental, questioning the assertion of irreversible damage. Hence, Option (d) is the correct answer.

Difficulty Level: Moderate



Explanation: a) This option suggests exclusivity in the solution to invasive species impacts, emphasizing human intervention as the sole viable approach. The passage's argument is broader, focusing on the urgency and scale of the threat rather than prescribing a singular form of response. Hence, Option (a) is not the correct answer.

- b) Describing the threat as not significant contradicts the sense of urgency and scale conveyed in the passage. The passage likely highlights the serious and growing nature of the threat posed by invasive species, calling for immediate and substantial action. This option, by suggesting insignificance, does not fully capture the passage's emphasis on the need for urgent and comprehensive responses to what is portrayed as an escalating problem. Hence, Option (b) is not the correct answer.
- c) This option succinctly encapsulates the main message of the passage, emphasizing both the urgency and the growing nature of the threat that invasive species pose to global biodiversity. It accurately reflects the passage's call for immediate action in response to this escalating threat, making it the most suitable inference as the passage's conclusion. The use of "urgent and escalating threat" aligns with the tone and content of the passage, summarizing its primary focus and call to action effectively. Hence, Option (c) is the correct answer.
- d) While the study of invasive species indeed may provide insights into ecosystem resilience and adaptability, this option diverts from the main argument of the passage. The focus on the value of studying invasive species, though relevant, does not directly relate to the passage's primary concern about the urgent threat posed by invasive species to global biodiversity. This option introduces a different focus and does not encapsulate the passage's main conclusion about the need for immediate action against the threat of invasive species. Hence, Option (d) is not the correct answer.


