READING COMPREHENSION

Q1. Option B is the correct answer. In the passage, the term "drubbing" is used to describe an expected significant defeat or loss for the Tories in the local elections. Similarly, in option B, "drubbing" is used to describe a significant negative outcome for the company in the stock market after its financial report disappointed investors. Both instances convey the idea of experiencing a significant setback or defeat. Options A and D are incorrect because they use "drub" to describe victories rather than defeats, and option C, while it correctly uses "drubbing" to describe a defeat, does not relate to the political context mentioned in the passage.

Q2. Option B is the correct answer. The passage suggests that the government's approach to addressing the financial crisis facing local authorities is described as "reactive and insufficient." This characterization implies that the government's response to the financial challenges faced by local authorities has been primarily reactionary, responding to immediate issues as they arise rather than implementing comprehensive, proactive measures to address the underlying problems. Additionally, the term "insufficient" suggests that the actions taken by the government may not be adequate or effective in adequately addressing the financial needs of local authorities. Overall, this characterization indicates that the government's approach is perceived as lacking in foresight and not fully addressing the magnitude of the financial crisis affecting local government. Options A, C, and D are incorrect because they do not accurately reflect the characterization of the government's approach provided in the passage.

Q3. Option A is the correct answer. The passage exhibits a formal writing style characterized using precise language, structured arguments, and a focus on factually presenting information. The author employs analytical techniques to discuss various aspects of the government's policies and their implications for local authorities. While the passage does present arguments and analysis, it does so formally and analytically, devoid of personal anecdotes, persuasive language, or descriptive storytelling, thus options B, C, and D stand incorrect.

Q4. Option A is the correct answer. "The" is used before "Institute for Fiscal Studies" because it refers to a specific organization, the one mentioned in the passage. A definite article rule has been used here.

Q5. Option D is the correct answer. Statement I stand incorrect although, it might seem plausible, as the passage discusses the government's decision to prioritize defence spending. However, the passage does not explicitly state that defence spending is prioritized over local governance concerns. Statement II stands incorrect although the passage mentions problems in certain local authorities resulting from risky commercial projects, it does not suggest that financial crises across local authorities are primarily caused by mismanagement. Statement II stands incorrect because the passage discusses predictions of a potential "drubbing" for the Conservative party in the local elections, with experts expecting them to lose seats. Therefore, it would be incorrect to infer that there will be a significant increase in support for the Conservative Party based on the passage, this option contradicts the information provided in the passage and is thus incorrect. Statement IV also stands incorrect because there is no information provided about the institute's historical stance on defence spending or whether it generally supports the government's policies in this regard.

Q6. Option B is the correct answer. Karl Marx, as discussed in the passage, suggests that the tendency to reach for historical parallels in times of crisis often serves to veil power grabs in a more compelling guise. Marx criticizes this tendency by arguing that during revolutionary crises, individuals and groups may conjure up historical symbols and language to present their actions as legitimate or heroic, even when they are motivated by self-interest or opportunism rather than genuine revolutionary ideals. Marx's critique highlights how historical analogies can be used as a tool for manipulation and deception, obscuring the true motives and consequences of political actions.

Q7. Option A is the correct answer. The passage engages in an analytical examination of Karl Marx's perspective on historical parallels and their use in political contexts. It critically evaluates Marx's views on how historical analogies can be employed to veil power grabs and manipulate perceptions during times of crisis. The passage also discusses various historical examples to illustrate Marx's point, indicating a critical assessment of past events concerning Marx's theories. Overall, the tone is characterized by analytical scrutiny and critical evaluation of historical and political phenomena, making option A the most appropriate choice.

Q8. Option A is the correct answer. This option directly strengthens the argument presented in the passage by providing evidence that historical analyses, particularly those that draw parallels between past

It reinforces the idea that historical analogies are influential in shaping public perceptions and policy decisions, which aligns with the main argument of the passage regarding the impact of historical parallels on political discourse. Therefore, if true, this option would indeed strengthen the argument presented in the passage. Options B, C, and D do not directly address or reinforce the argument presented in the passage regarding the influence of historical parallels on political discourse, which is why they are considered incorrect.

Q9. Option B is the correct answer. The modal verb "can" is the most appropriate choice to complete the sentence in the context of the passage. The use of "can" suggests the ability or possibility for political leaders to utilize historical symbolism and language during times of crisis to shape public perceptions. It implies that they have the capability or opportunity to do so, without necessarily implying obligation or necessity.

Q10. Option C is the correct answer. In the passage, the word "veil" is used in the context of discussing how historical parallels can be employed to conceal or disguise power grabs and manipulative actions during times of crisis. When something is veiled, it is hidden or obscured from view, often to conceal its true nature or intentions. In this case, the passage suggests that historical analogies can be used as a veil to obscure the true motives behind political actions.

Q11. Option C is the correct answer. The purpose of the Dormio device, as described in the passage, is to simulate the experience of reading through dreaming by triggering specific dream scenarios based on the first lines of unfamiliar poems. Will Dowd listen to recordings of the first lines of poems that are unfamiliar to him and use those as seed phrases to push his dream in a certain direction? The Dormio device then wakes him up during the dream state, allowing him to recall and write down every sensory detail and a leap of logic experienced during the dream.

Q12. Option D is the correct answer. In the passage, the word "lurch" is used metaphorically to describe a sudden, unexpected change or shift in direction. It conveys the idea of moving abruptly or unsteadily away from a certain direction or path. In the context of the passage, the protagonist's condition of binocular vision disorder causes words to drift across the page, getting tangled up in one another, which disrupts his ability to read and comprehend. This disruption leads to a figurative "lurch" in his ability to navigate through written text, symbolizing the sudden shifts and difficulties he experiences.

It specifies that the grant originated or was provided by the Woodberry Poetry Room at Harvard University. Option A, "from," accurately reflects the preposition used in the passage to denote the source of the grant. Therefore, it is the correct answer.

Q14. Option A is the correct answer. This best encapsulates the main theme of the passage, which revolves around Will Dowd's project titled "Dream Fall." The passage discusses Dowd's exploration of the connection between reading and dreaming, as well as his use of the Dormio device to simulate the reading experience through dreaming. This title effectively captures the essence of Dowd's project and the central theme of exploring the intersection between reading and dreaming.

Q15. Option A is the correct answer. The argument presented in the passage suggests that Will Dowd's use of the Dormio device, coupled with his condition of binocular vision disorder, allows him to simulate the experience of reading through dreaming. This implies a connection between his condition and the effectiveness of the Dormio device in triggering specific dream scenarios. Option A weakens this argument by introducing the possibility that individuals with binocular vision disorder are naturally more prone to experiencing vivid and lucid dreams, regardless of the use of the Dormio device. If this were true, it would suggest that Dowd's success with Dream Fall may be more attributed to his condition rather than the effectiveness of the Dormio device itself.

Q16. Option B is the correct answer. In the passage, Mallikarjun Kharge suggests that Prime Minister Narendra Modi's focus on "mangalsutra and Muslims" in his speeches is a diversionary tactic. Kharge implies that Modi brings up these topics to distract from his government's shortcomings and failures. Kharge's statement indicates a belief that Modi is using these issues to shift public attention away from other pressing issues or criticisms of his leadership.

Q17. Option C is the correct answer. *Hyperbole is a literary device characterized by exaggerated statements or claims that are not meant to be taken literally.* In the given excerpt, Mallikarjun Kharge suggests that Prime Minister Narendra Modi constantly talks about "Mangal sutra and Muslims" in his speeches. This statement is likely exaggerated for effect, as it portrays Modi as excessively focused on these topics. Kharge's use of hyperbole serves to emphasize his point that Modi is intentionally diverting attention from other issues by repeatedly bringing up certain topics in his speeches.

Therefore, option A is the best inference that can be drawn from Kharge's statements.

Q20. Option C is the correct answer. From Kharge's remarks in the passage, particularly his criticism of Modi's focus on "mangalsutra and Muslims" in his speeches, it can be inferred that Kharge assumes that most voters are influenced by issues related to religion and identity. Kharge's comments suggest that he believes Modi is deliberately targeting these sensitive topics to sway public opinion, indicating an assumption that such issues hold significance for voters.

Q21. Option C is the correct answer. The passage highlights O'Shaughnessy's association with the Tavistock Clinic and her adherence to the Kleinian tradition of psychoanalysis. It provides insights into the therapeutic approach of Edna O'Shaughnessy. It is supported by the detailed examination of O'Shaughnessy's

Option A (a memoir) is less likely because the passage lacks personal reflections or subjective experiences typically found in memoirs. Option C (a critical analysis) is less suitable as well, as the passage does not extensively critique psychoanalytic methods but rather presents O'Shaughnessy's approach without significant evaluation. Option D (an obituary or tribute) is less probable since the passage focuses more on O'Shaughnessy's professional work and approach to psychoanalysis rather than reflecting on her life achievements in an obituary format. Therefore, option B is the most fitting choice given the content and tone of the passage.

Q23. Option A is the correct answer. This is evident from the line: "The merest glance at Leon in their first encounter in what O'Shaughnessy called the 'playroom' told her that a daunting challenge lay ahead." The word "daunting" suggests that O'Shaughnessy found the task or situation of working with Leon to be intimidating or challenging. This indicates the initial impression she had of Leon's condition or demeanour during their first meeting.

Q24. Option A is the correct answer. The passage exhibits an academic and analytical writing style characterized by a focus on presenting information in a scholarly manner and analysing the subject matter in depth. It provides insights into the therapeutic approach of Edna O'Shaughnessy, a leading child psychoanalyst, with a detailed examination of her analysis of an 11-year-old boy named Leon. The passage presents information objectively, discussing O'Shaughnessy's approach and its implications without personal bias or emotional reflection. Additionally, the passage includes references to concepts and theories related to psychoanalysis, indicating an academic context.

Q58. Option B is the correct answer. Mukesh is not entitled to ask for money from the merchants because he made investments to improve the market at the request of the collector, not the shopkeepers. This option implies that there was no explicit agreement or contractual arrangement between Mukesh and the merchants regarding the commission.

Rahul's activities, albeit lacking a formal contract, could potentially impose an obligation on the government to reimburse Priya under Section 70 of the Indian Contract Act. This is because Rahul's actions have benefited Priya and may have established a contractual obligation for compensation.

The court will mandate that Priya's claim for compensation be taken into account. While Rahul's nongratuitous activities of covering Priya's shifts are advantageous for Priya, they seem to impose a responsibility on the government to reimburse her for the value of her job. According to Section 70 of the Indian Contract Act, he is obligated to repay her this amount.

Option A: This option is incorrect because the passage explicitly states that Teixeira's leaks lack the moral clarity and ethical underpinning of Manning and Snowden's actions, and that they have not led to policy dialogue or reforms. Option B: This option is incorrect because the passage explains that the leaks have fueled insecurity between the U.S. and other global powers, rather than increasing cooperation and trust. Option D: This option is

incorrect because the passage does not mention any increase in cyber-attacks as a direct consequence of the leaks.

Q87. Option C is the correct answer. As the passage emphasizes the negative consequences of Jack Teixeira's actions. It states that the leaks discredited the war effort of Ukraine and its western allies, potentially undermined their tactical plans, and fueled insecurity between the U.S. and other global powers. This can be seen in the first paragraph: "it is obvious that the dots join to paint a clear picture of Mr. Teixeira's intention to discredit the war effort of Ukraine and its western allies and show up the Biden administration in a bad light amongst its global partners." Option B: This option is incorrect because the passage asserts that the leaks have fueled insecurity between the U.S. and other global powers, rather than fostering collaboration. Option D: This option is incorrect because the passage does not mention any reduction in military conflicts or tensions as a result of the leaks; instead, it highlights the potential harm to Ukraine's war efforts and U.S. national security interests.

Q88. Option A is the correct answer. As it directly contradicts the author's argument that the leaks have discredited the war effort of Ukraine and its western allies, and potentially undermined their tactical plans. If the leaked information actually helped Ukraine and its allies devise new strategies leading to more effective war efforts, the author's arguments would be weakened. The author's stance can be found in the first paragraph: "it is obvious that the dots join to paint a clear picture of Mr. Teixeira's intention to discredit the war effort of Ukraine and its western allies and show up the Biden administration in a bad light amongst its global partners." Option B: This option is incorrect because, even if Jack Teixeira had a personal grievance, the passage's main focus is on the consequences of his actions, which would not be significantly altered by his intentions. Option C: This option is incorrect because, even if the leaked information was outdated, the author's argument that the leaks have fueled insecurity between the U.S. and other global powers would still stand. Option D: This option is incorrect because even if the leaked information of Ukraine's position. Many would not buy this justification. Therefore, it does not weaken the author's argument. Also, the option expresses the reason (to salvage the situation).

Option D: This option is incorrect because the passage does not assert that the leaked information revealed only negative aspects of U.S. foreign policy decisions; it focuses on the specific consequences of the leaks on international trust and Ukraine's war efforts.

Instilling the idea of gender equality and justice with the help of Education may help to reduce the impact as author is supporting it with the help of Haryana (progressive ideas).

It identifies the key challenges and conflicts that arise from the process, such as linguistic, cultural, economic, political, etc. It reflects the author's critical perspective on the existing provisions and arrangements, and their implications for different communities. Option C is incorrect because it only describes the legal and constitutional provisions, but not their effects and consequences on the sociocultural and economic aspects of Manipur and its people It does not capture the complexity and diversity of the state reorganisation process. It does not reflect the author's critical perspective on the existing provisions and arrangements. It does not mention the demands for statehood that persist in some regions. Option D is incorrect because it implies that the passage is making an argument or a recommendation for a more inclusive and equitable state reorganisation in India, which is not the case.
