Answer: B

Explanation: B. Correct: The passage directly states that "some vices are selected for, and reinforced by, the structure of competitions. They make us stronger competitors." The example of "intransigence" – continuing to play when one should stop – is presented as a vice that can benefit an athlete's competitive performance.

- A. Incorrect: While the passage acknowledges that humans are "flawed, confused, complex," it doesn't claim that all athletes are inherently flawed. The passage points to specific vices and their potential origins, but it does not generalize about athletes' moral character as a whole.
- C. Incorrect: The passage states that "masking agents substances such as diuretics that, while not themselves performance-enhancing, can disguise the presence of substances that are." This explicitly indicates that masking agents are not always considered performance-enhancing, but rather are used to hide the presence of other substances.
- D. Incorrect: The passage does not argue that athletic excellence inevitably leads to vice. It explores the complex relationship between vices and sports, acknowledging that some vices may be present due to human flaws, cultural narratives, or even competitive structures, but it does not draw a direct causal link between athletic excellence and the development of vices.

Answer: A

Explanation: A. Correct: "Evoke" means to bring or call forth a feeling, memory, or response. In this context, it perfectly replaces "elicit" by implying that the prohibited performance enhancement methods bring forth a response in the athlete's biological markers, which are then detected by the ABP. It highlights the process of eliciting a measurable response from the body.

Incorrect Answers:

- B. Incorrect: "Solicit" means to ask for or try to obtain something, often by persuasion. This doesn't fit the context because the sentence isn't about asking for or obtaining performance enhancements, but rather the detection of their use.
- C. Incorrect: "Procure" means to obtain something, especially with care or effort. While this word can sometimes be used for illegal activities, it doesn't directly relate to the idea of eliciting a response from the body, which is the key aspect of the sentence.
- D. Incorrect: "Induce" means to persuade someone to do something, or to cause something to happen. While it can be used in the context of eliciting a response, it doesn't specifically address the illicit nature of the performance enhancement methods as clearly as "evoke" does.

Answer: A

Explanation: A. Correct: The passage is candid because it openly discusses the prevalence of doping in athletics, even though the author acknowledges it might be naive to think that eye contact during drug testing would deter cheating. The author is also clearly frustrated by the situation, evidenced by phrases like "This might press us to wonder," "This should not come as a surprise," and "There is an epidemic of cheating behaviours."

Incorrect Answers:

- B. Incorrect: While the author expresses hope that drug testing and the Athlete Biological Passport will help to deter cheating, the passage overall is not hopeful or optimistic. The author's frustration with the pervasive nature of doping overshadows any optimistic outlook.
- C. Incorrect: The passage is analytical in its examination of the problem of doping, but it lacks the detached and impartial tone often associated with purely objective writing. The author's personal feelings and opinions are evident throughout the piece.



D. Incorrect: While the author is aware of the prevalence of cheating, the passage does not express a sense of resignation. The author still believes that athletes should compete fairly, and they explore the ethical and psychological aspects of doping in a way that suggests a desire for change rather than acceptance.

4. Answer: C

Explanation: C. Correct: The passage suggests that the inherent value placed on winning and the heroworship of athletes within sports culture create a climate that normalizes and even encourages unethical behaviour. The author states that "some of these vices are concessions to a cultural narrative that prizes sport and celebrates athletes as exceedingly valuable people," directly linking the problematic behaviour to the broader societal attitudes towards sports.

Incorrect Answers:

- A. Incorrect: While the passage does acknowledge that humans are flawed, it doesn't explicitly state that societal values are inherently flawed. The author's argument is more nuanced, suggesting that certain aspects of sports culture, rather than general societal values, contribute to the problem of vice.
- B. Incorrect: While the passage acknowledges the pressures of competition, it doesn't claim that these pressures alone are the sole cause of unethical behaviour. The author explicitly links the behaviour to the cultural narrative surrounding athletes and winning.
- D. Incorrect: The author does suggest that sports can reflect societal values, but they don't explicitly argue that sports can influence or shape those values. The passage's focus is on how societal values, specifically those surrounding athletes and winning, contribute to the problem of unethical behaviour in sports.

Answer: B

Explanation: B. Correct: This option captures the core of the author's argument. The passage highlights the tension between the perceived deterrent effect of drug testing and the reality of widespread doping. The author points to the "epidemic of cheating behaviours" and the fact that "those who get away with it often outperform athletes who compete above reproach." This suggests that despite measures to deter cheating, the pressures and rewards within sports culture create an environment that encourages unethical behaviour.

Incorrect Answers:

- A. Incorrect: The passage doesn't explicitly argue that ethical behaviour is inherently incompatible with athletic performance. The author acknowledges human flaws, but they don't suggest that ethical behaviour is impossible within the context of sports.
- C. Incorrect: The author doesn't portray athletes as having an inherently intact moral compass. They acknowledge that athletes, like all humans, are subject to flaws and are influenced by cultural narratives. The passage's focus is on how the current structure of sports incentivizes unethical behaviour, not on the inherent moral character of athletes.
- D. Incorrect: While the passage hints at the tension between individual achievement and human limitations, it doesn't frame the issue as a choice between ethics and maximizing performance. The author's focus is on the role of cultural pressures and the incentive structure within sports that contribute to the problem of doping.

6. Answer: C

Explanation: C. Correct: The passage explicitly mentions that the ABP "is a longitudinal means of assessing whether an athlete has participated in elicit forms of performance enhancement, achieved by monitoring biological markers that shift in response to certain drugs long-term." This implies that the ABP



system is designed to track changes in an athlete's body over time, which can reveal potential health risks associated with doping or even excessive training.

Incorrect Answers:

- A. Incorrect: The passage doesn't suggest that the ABP system reduces the need for immediate post-race testing. The ABP acts as a complementary system to immediate testing, providing a longer-term perspective.
- B. Incorrect: While the ABP focuses on long-term patterns, the passage doesn't suggest that it incentivizes athletes to seek new undetectable substances. The system aims to detect long-term patterns, making it more difficult for athletes to avoid detection.
- D. Incorrect: The passage emphasizes the ABP's ability to detect long-term changes but doesn't claim to completely eliminate masking agents. Masking agents are specifically mentioned as a factor that needs to be considered, suggesting that the ABP system doesn't completely negate their use.

7. Answer: B

Explanation: B. Correct: The passage uses a first-person narrative ("I cross the finish line..."), reflecting on the personal experience of undergoing drug testing. The author grapples with the moral implications of doping, questioning whether it's truly a deterrent and exploring the broader societal implications of sportsmanship and cheating. This personal and introspective approach is characteristic of a personal essay.

Incorrect Answers:

- A. Incorrect: While the passage mentions doping and its impact, it lacks the objective and scientific analysis typical of a scientific article. There is no systematic data or research cited.
- C. Incorrect: The passage touches upon the prevalence of doping, but its focus is broader, examining the moral and ethical questions surrounding the issue rather than simply reporting on statistics.
- D. Incorrect: While the passage delves into the relationship between virtue and athletic success, it doesn't present a structured philosophical argument or analysis. It's more of a personal reflection on the topic.

8. Answer: C

Explanation: C. Disillusioned: This is the most accurate representation of the author's tone. The author is clearly troubled by the prevalence of doping. Their initial hopefulness, evident in the "naive" belief that the drug test itself would be a deterrent, is quickly shattered by the reality of the situation. The phrase "epidemic of cheating behaviours" and the statistic of 567 ineligible athletes underscore the author's disillusionment with the current state of the sport.

Incorrect Answers:

- A. Hopeful: The passage doesn't portray a hopeful perspective. While the author highlights the importance of testing and the value of ethical competition, the overall tone is pessimistic. The author's focus on the vast scale of doping and its consequences for the sport contradicts any sense of hope.
- B. Accepting: The author is not accepting the situation. The passage emphasizes the negative impact of doping and the need for change. The author's use of phrases like "epidemic" and "wayward actions" highlights their disapproval and concern.
- D. Indifferent: The author's detailed exploration of doping, its impact on athletes, and its connection to broader ethical issues demonstrates a clear engagement with the topic, far from indifference. They clearly care about the integrity of the sport and are troubled by the current state of affairs.

9. Answer: B

Explanation: B. Analytical, Dismissive: The author presents Freud's theory with a clear analytical approach, outlining the key points of his argument. However, the author also expresses a degree of dismissal towards Freud's perspective. This is evident in phrases like "there is some anthropological and



theological heft to his point" and "almost all ancient religions featured some kind of petitionary prayer," which suggest that while the author acknowledges Freud's theory, they don't fully subscribe to it. The tone is more analytical than reverent or sympathetic.

Incorrect Answers:

- A. Reverent, Critical: The author does not approach Freud's perspective with reverence. The passage presents the theory with a neutral tone, emphasizing the analytical aspect, not the emotional response. While the author might be critical of some aspects of Freud's theory, the overall tone is not strongly critical.
- C. Humorous, Sympathetic: The passage lacks humour, and the author does not express any sympathy towards Freud's perspective. Instead, they maintain a more objective and critical stance. The author's goal is to explain Freud's theory, not to humorously endorse or sympathize with it.
- D. Scholarly, Respectful: The author does employ a scholarly tone, clearly presenting Freud's ideas and supporting them with examples. However, the author also subtly critiques some of Freud's assumptions, suggesting that they hold a more nuanced perspective. While respectful of Freud's work, the author doesn't fully embrace it.

10. Answer: B

- C. Conciliatory: "Conciliatory" refers to an action aimed at reconciling or appeasing. It emphasizes the goal of achieving harmony, which is not the primary focus of "intercessory perks," which are about obtaining specific benefits.
- D. Exemplary: "Exemplary" means serving as a model or example. It doesn't have any connection to the idea of mediation or intercession.

11. Answer: B

Explanation: B. Correct: The passage, starting with the anecdote of the French Wars of Religion, establishes the context of petitionary prayer and its potential for conflicting requests. The author explores the broader philosophical and psychological dimensions of religious belief, including the evolution of faith and the inherent desire for control over uncontrollable forces.
- C. Incorrect: The passage doesn't explicitly argue that the evolution of religious beliefs is driven by a growing understanding of human psychology. While it mentions Freud's perspective and how fear might have fueled early religious practices, it doesn't propose that later religious beliefs are inherently superior due to a deeper understanding of human nature.
- D. Incorrect: The passage does mention the enduring presence of petitionary prayer, but it doesn't suggest that it is the fundamental expression of human vulnerability. Instead, it highlights the limitations of viewing



prayer solely as a means of seeking personal benefits and emphasizes the more profound psychological and philosophical underpinnings of religious belief.

It emphasizes the dangerous and chaotic nature of the world for early humans, leading them to invent gods to provide control and meaning in the face of this fear.

- B. Incorrect: The passage discusses how the fear of death is a central motivator for religious behaviour. While it doesn't explicitly state that this is the only motivation, it emphasizes the desire to control uncontrollable forces, including the fear of mortality, which religion offers a way to confront and manage.
- D. Incorrect: The passage clearly connects the fear of death to the development of religious beliefs. It states that fear of death is a fundamental human anxiety and suggests that religion provides a way to cope with this fear by offering meaning and solace in the face of mortality.

13. Answer: D

Explanation: D. Correct: The statement "We can imagine ourselves taking control over nature via God" implies a fundamental human desire for control, which Freud's theory attributes to the fear of natural forces. However, the addition of "anthropological and theological heft" signifies a broader dimension to religious belief that goes beyond individual psychology. A. Incorrect: While the statement does acknowledge the "anthropological and theological heft" of Freud's point, it doesn't solely focus on the tool aspect of religion for control. The passage suggests a deeper dimension to religious behaviour beyond simply control, indicating a more complex interplay of factors.

- B. Incorrect: The passage does not explicitly highlight a paradox in Freud's theory. The statement implies a broader context for understanding religion than just psychology, not a contradiction within Freud's own framework.
- C. Incorrect: While the passage acknowledges the "anthropological and theological heft," it doesn't explicitly suggest a need for a "more comprehensive understanding." The statement primarily points to the limitations of a purely psychological explanation, without explicitly advocating for a different approach.

14. Answer: A

- C. Incorrect: Perspicacity refers to the ability to understand things clearly and keenly, focusing on intellectual insight rather than foresight. While perspicacity can be a component of wisdom, it doesn't encompass the broader understanding of the past, present, and future that is implied by omniscience.



D. Incorrect: Ubiquity refers to being present everywhere at the same time. While the concept of God's omnipresence is often discussed, it doesn't directly relate to the specific aspect of wisdom and foreknowledge implied by omniscience in the context of the sentence.

15. Answer: B

- D. Incorrect: While the passage has moments of humour, like the analogy of God as an "overindulgent grandma," the overall tone isn't primarily humorous. The author's primary focus is on providing a thoughtful and insightful exploration of the topic, not on generating laughter.

- B. Incorrect: The passage highlights that early humans sought to control nature through their interactions with the gods they created. This desire for control is evident in the examples of praying for rain or crops, and negotiating with gods to mitigate the effects of natural disasters.
- C. Incorrect: The passage explicitly states that Freud believed humans created gods as a means to project their anxieties onto external entities. The author outlines this concept by saying, "We threw light into the darkness and rationalized the irrational. We gave nature a personality with whom we could beg, worship, and negotiate." This aligns directly with Freud's theory of projection as a defense mechanism.

17. Answer: C

Explanation: C. Correct: The passage states that "Taryn would learn from a rheumatologist that her symptoms were most likely caused by mixed connective tissue disease (MCTD), a rare autoimmune condition, not a mental illness." This indicates that the medical understanding of autoimmune diseases was limited in the 1980s, leading to Taryn's initial misdiagnosis.

A. Incorrect: While Taryn was initially diagnosed with IBS, it was never confirmed as an eating disorder like anorexia nervosa. Her hospitalization was for her severe malnutrition, and while the doctors suspected an eating disorder, it wasn't definitively diagnosed.

B. Incorrect: The passage states that Taryn was hospitalized due to her severe malnutrition. Her hospitalization wasn't delayed because of a lack of recognition of the severity of her condition; it was a direct consequence of her weight loss and inability to eat.



D. Incorrect: While the passage mentions that Taryn completed nursing school, it does not link this accomplishment to her negative experiences with the medical system. It explicitly states that she was motivated by her early childhood experience of caring for an ailing relative.

18. Answer: B

Explanation: B. Correct: The passage explicitly states that Taryn managed to complete both college and nursing school "somehow, through all of this." This implies that her academic achievements were remarkable given the significant challenges she faced. The passage further highlights her struggle with exhaustion, weakness, and malnutrition, suggesting that these physical limitations would have posed substantial obstacles to her education. Therefore, the inference that Taryn's resilience and determination were key to her academic success is strongly supported by the text.

Explanation for Incorrect Answers:

A. Incorrect: While the passage mentions Taryn's distrust of the medical system, it does not explicitly link this to a broader skepticism towards authority figures or provide evidence that it influenced her career choices. The passage focuses on her motivation to pursue nursing stemming from her childhood experience, not her distrust of authority.

- C. Incorrect: The passage does not explicitly state that Taryn was motivated by a desire to help others facing similar challenges. Her motivation is attributed to her childhood experience of caring for an ailing relative, not her personal struggles with the medical system. While the experience could have influenced her empathy, the passage does not provide concrete evidence of this link.
- D. Incorrect: The passage doesn't explicitly discuss Taryn's future practices or her approach to patient care. While it is plausible that her experiences instilled empathy, the passage focuses on her academic achievements and the challenges she faced due to her illness and the medical system's response.

19. Answer: A

Explanation: A. Correct: The word "persistent" accurately captures the meaning of "chronic" in this context. It signifies that the illnesses, including IBS, fibromyalgia, and chronic fatigue syndrome, are characterized by their long-lasting nature, continuing over a prolonged period. The sentence implies that these illnesses are not easily cured or resolved, making "persistent" an appropriate synonym.

Explanation for Incorrect Answers:

- B. Incorrect: "Endemic" refers to a disease that is prevalent in a specific geographic location or population. While IBS, fibromyalgia, and chronic fatigue syndrome might be prevalent in certain populations, the sentence does not focus on their geographic distribution. "Endemic" does not accurately convey the concept of a condition lasting for an extended period.
- C. Incorrect: "Recurrent" implies that a condition comes back repeatedly after periods of remission. While some forms of IBS or fatigue syndrome can be recurrent, the sentence focuses on the overall lasting nature of these conditions, not just their recurrence.
- D. Incorrect: "Inveterate" refers to a deeply rooted habit or tendency. While this could be applied to a person's experience with a chronic illness, it doesn't accurately capture the characteristics of the illnesses themselves. The sentence focuses on the enduring nature of these conditions, not on any particular habit or tendency associated with them.

20. Answer: C

Explanation: C: The passage conveys a critical tone towards the medical system that repeatedly misdiagnosed Taryn and a sympathetic tone towards her struggles and the impact of those misdiagnoses on her life. The author criticizes the medical community's approach to Taryn's condition, highlighting the stigma associated with illnesses like IBS and eating disorders. Simultaneously, the passage expresses



sympathy for Taryn's suffering and the trauma she experienced due to the lack of proper diagnosis and treatment

- A. Skeptical and Dismissive This option is incorrect because the passage does not express doubt or disbelief regarding Taryn's condition; rather, it challenges the medical community's handling of her case.
- B. Optimistic and Hopeful This option is incorrect as the passage does not convey a positive outlook or expectation for Taryn's situation. It focuses on the negative aspects of her experience with the healthcare system.
- D. Indifferent and Neutral This option is incorrect because the passage is not impartial or unemotional. It clearly communicates concern and criticism, indicating a stance that is far from indifferent.

21. Answer: C

The author uses the term 'abstract' to describe the process of mentally pulling apart elements that are experientially grown together.

B. This option is incorrect as the passage does indeed discuss happiness as a complex response to perceived good things in life, suggesting that it encompasses more than just fleeting moments of joy. D. This option is incorrect because the passage does address the concept of abstraction in philosophical inquiry, describing it as the act of reflectively separating elements of experience that are, in fact, inseparable.

22. Answer: C

Explanation: C: The correct answer is C because the passage suggests that happiness is not merely about the present moment or isolated fragments of joy. Instead, it is described as a response to the 'wholes' of life, which include events and processes that span across time, integrating the past, present, and future. The author emphasizes that happiness is about the entirety of life's experiences, not just momentary sensations

- D. This option is incorrect because the passage explicitly argues that happiness is not defined solely by momentary pleasures. It is a more complex response that involves the good aspects of life as a whole.

23. Answer: B

This synonym fits the context of the passage, which discusses the inseparable and enduring nature of life's 'wholes' that include the lived past, present, and future. Explanation of Other Options: A. Irretrievably - This option is incorrect because "irretrievably" implies something that cannot be recovered or reversed, which does not align with the context of the passage.

C. Intricately - This option is incorrect as "intricately" suggests something that is very complicated or detailed, which is not the focus of the passage's use of "inextricably."



D. Indistinguishably - This option is incorrect because "indistinguishably" means in a way that cannot be identified as different or distinct, which does not convey the same meaning as "inextricably" in the context of the passage.

24. Answer: B

- C. This option is incorrect as the passage explicitly argues against the idea that the present moment alone offers happiness. It states that happiness encompasses the past, present, and future.
- D. This option is incorrect because the passage does not critique philosophical inquiry itself. Rather, it critiques the abstraction of the present moment from the larger context of life's events in such inquiries.

25. Answer: B

The agreement says members must not seek, take or maintain any voluntary export restraints, orderly marketing arrangements or any other similar measures on the export or the import side.


