Incorrect options:

Option (a) "Reduction" is incorrect because it implies the opposite of "splurge." "Reduction" refers to the act of decreasing or diminishing something, which is not consistent with the context of the passage discussing a large financial expenditure.

Option (c) "Delay" is incorrect because it refers to postponing or putting off something, which is unrelated to the concept of spending money or making an investment.

Option (d) "Analysis" is incorrect because it pertains to the examination or study of something in detail, which does not align with the context of financial expenditure discussed in the passage.

Reference line: "Microsoft, for instance, is reportedly planning a \$100 billion splurge into a supercomputer – set to go online in 2028 – to back its AI ambitions."

Answer: B

Option (c) "The Environmental Cost of Artificial Intelligence Research" is incorrect because although the passage briefly touches upon the energy consumption of large language models, it is not the central theme or focus of the passage.

Option (d) "The Competition Between Tech Giants in Supercomputer Development" is incorrect because while the passage mentions Microsoft's investment in a supercomputer, it is just one aspect of the discussion on Al infrastructure and not the main focus of the passage.

Reference line: "Here's everything you need to know about SLMs."

Answer: B

Option (c) "Enthusiastic about the potential of supercomputers in AI" is incorrect because while the passage mentions Microsoft's investment in a supercomputer, it does not convey enthusiasm about



supercomputers in general. The discussion on supercomputers is presented in a factual manner without expressing particular enthusiasm.

Option (d) "Dismissive of the effectiveness of small language models" is incorrect because the passage highlights the effectiveness and advantages of small language models, rather than dismissing them. It discusses how SLMs are proving to be highly effective in specialized tasks and resource-constrained environments, indicating a positive view of their effectiveness.

Reference line: The overall tone of the passage, characterized as informative and objective, is evident throughout the entire passage as it presents factual information about the development and advantages of small language models (SLMs) without expressing overt criticism or enthusiasm.

4. Answer: B

Option (c) "The lack of security measures in place for small language models" is incorrect because the passage does not address security concerns related to SLMs. It primarily focuses on their effectiveness, versatility, and potential applications.

Option (d) "The potential job losses in the tech industry due to AI advancements" is incorrect because the passage does not discuss job losses in the tech industry or express concern about this issue. Its main focus is on the emergence and advantages of small language models and their impact on AI research.

Reference line: "The high energy consumption required by large language models."

Answer: C

Incorrect options:

While SLMs offer advantages in specialized tasks, LLMs still have their own applications and domains where they excel

Option (b) "Increased collaboration between big tech companies in AI research" is incorrect because the passage does not address collaboration between companies. It focuses on the development and advantages of SLMs rather than collaboration dynamics.

Option (d) "A shift towards cloud-based deployment for all language models" is incorrect because the passage does not specifically discuss a shift towards cloud-based deployment. It highlights the deployment of SLMs on edge devices and resource-constrained environments, suggesting versatility in deployment options rather than a specific shift towards cloud-based deployment.

6. Answer: A

Option (c) Hyperbole involves exaggeration for emphasis or effect. While the sentence describes the cupolas as shining brightly, it does not exaggerate to an extreme degree, so it does not qualify as hyperbole.

Option (d) Personification attributes human characteristics to non-human entities. Since the sentence does not attribute human qualities to the cupolas, it does not fit the definition of personification.

Therefore, the sentence is best described as a simile because it uses "brighter" to directly compare the brightness of the cupolas to the sunlight on a scalding summer day.

Therefore, "lush green haven" best captures the meaning of "verdant oasis" as it reflects the peaceful and green nature of the Government Museum campus amidst the chaos of Egmore.

Reference line: The phrase "verdant oasis" is from the sentence: "Nestled inside the calm, verdant oasis of the Government Museum campus."

8. Answer: B

Option (c) The long-drawn renovation project was sanctioned for ₹ 12 crores provides information about the cost of the renovation but does not specifically relate to the architectural features of the building.

Option (d) The upkeep of the facade relies on sourcing pink sandstone from Andhra Pradesh describes maintenance of the building but does not directly relate to its status as an architectural marvel.

Therefore, the statement that best supports the argument that the National Art Gallery is an architectural marvel is that the facade is replete with bulbous domes, pointed arches, and jaali work.

Option (c) "Unmarried" is related to the context of bachelorhood but fails to provide a direct antonym for "permanent." Being unmarried does not inherently imply a temporary status; one could be unmarried temporarily or permanently. Thus, option (c) does not accurately contrast with the concept of permanence conveyed by "perma-bachelor."

Option (d) "Stoic" is entirely unrelated to the concept of permanence or bachelorhood. While emotional resilience may be a component of Stoicism's appeal, it does not directly contribute to its resurgence in modern culture.

Option (d) ("The challenges of managing and protecting soil for future generations") is a specific aspect discussed in the passage but does not encompass the broader theme of the importance of scientific understanding for sustainable development.

Option (d) ("A source of contamination for air and water resources") is incorrect because it misinterprets the role of soil described in the passage. Soil is depicted as facilitating the migration and retention of essential elements, rather than as a source of contamination.

Option (c) To create a sense of mystery surrounding the source of the filth is incorrect because the simile is used to describe the extent of the filth, not its source. The comparison emphasizes the overwhelming nature of the dirt, rather than leaving its origin shrouded in mystery.

Option (d) To compare the Ayemenem House to a historical landmark is incorrect because the simile compares the filth to a medieval army, not the house itself. The comparison serves to emphasize the pervasive and invasive nature of the dirt, rather than making a direct comparison to a historical landmark.

Option (d) The busker's dream was to be featured on a show despite interruptions is incorrect because while the busker may have dreamed of being featured on a show, the passage does not provide evidence to support the idea that he desired interruptions. Instead, it portrays being stopped by Phil Donahue as a positive experience for the busker.




India's defence exports (in Rs crore) and year-on-year change (%)

The focus here is on a broader trend rather than directly addressing the potential drawbacks or limitations of Rupee transactions in reducing costs. Hence, Option c) is not the correct answer.
- d) Special rupee Vostro accounts are widely praised for cutting costs, supporting the argument for Rupee trade's efficiency. By emphasizing the positive reception of Vostro accounts, this option reinforces rather than weakens the argument for the Rupee's role in reducing transaction costs. The praise for Vostro accounts suggests they are an effective mechanism for facilitating Rupee trade, aligning with the argument's premise that such trade can be cost-effective. However, this option fails to challenge the claim or introduce any considerations that might diminish the perceived benefits, making it unsuitable as a counterargument. Hence, Option d) is not the correct answer.

Difficulty Level: Easy

The parallel here is clear: both scenarios seek to streamline financial transactions by limiting the need for multiple currencies, making it the correct answer.
- b) An online marketplace implements a policy requiring all transactions to be conducted in its own virtual currency to streamline operations and enhance security. While this scenario shares similarities with the concept of using a single currency for simplicity and efficiency, it diverges by focusing on the creation of a virtual currency and the motives of operational streamlining and security enhancement. The core reasoning behind countries' interest in Rupee transactions—reducing transaction costs and avoiding currency exchange hassles—is not directly mirrored here. Hence, Option b) is not the correct answer.
- c) A local business exclusively accepts payments in the local currency to support the community and avoid exchange rate fluctuations. This scenario highlights the benefits of using a local currency for stability and community support but does not fully capture the mutual benefits and international trade focus of Rupee transactions. While avoiding exchange rate fluctuations is a shared benefit, the scenario is more inward-looking, focusing on local transactions rather than international trade dynamics that underpin the interest in Rupee transactions. Hence, Option c) is not the correct answer.
- d) A software company adopts a global pricing model, charging customers in their local currency to increase market penetration and customer satisfaction. Although this scenario addresses the adaptation to local currencies for strategic business reasons, it centers more on pricing strategies and customer experience rather than on simplifying transactions and minimizing exchange-related costs. The intent here is more aligned with marketing and sales tactics, diverging from the primary rationale of reducing costs and simplifying international trade processes through Rupee transactions. Hence, Option d) is not the correct answer.

Difficulty Level: Easy

- b) Rupee Vostro account setups by Indian banks are vital for the Rupee's global integration. This statement aligns with the passage's discussion on mechanisms facilitating the Rupee's acceptance and usability in international trade. Vostro accounts are crucial for enabling foreign transactions in Rupees, serving as a foundational element for the currency's broader adoption. The passage suggests that such infrastructural developments are key to integrating the Rupee globally, indicating the author's likely agreement with this statement. Therefore, Option b) is not the correct answer because the author would probably agree with it.
- c) Local currency trading, including with the Rupee, boosts financial stability and independence. This option reflects the passage's positive view on the benefits of trading in local currencies, such as enhancing financial stability and fostering economic independence. By reducing reliance on dominant reserve



currencies and promoting local currencies in international trade, countries can potentially achieve greater control over their economic policies and minimize exposure to external financial shocks. The author's arguments in favour of Rupee trading and the broader trend towards local currency usage suggest an agreement with this statement. Hence, Option c) is not the correct answer because the author would likely agree with it.

d) The trend of countries trading in their domestic currencies is short-lived and unsustainable. This statement directly contradicts the passage's narrative, which highlights the growing interest and perceived advantages of trading in domestic currencies, including the Indian Rupee. The passage implies that this shift represents a significant and potentially lasting change in global trade practices, favouring financial stability, independence, and reduced transaction costs. By suggesting that the trend is unsustainable, this option stands in opposition to the author's optimistic view of the future of domestic currency trading. Therefore, the author would most likely disagree with this statement, making Option d) the correct answer.

95. Answer: B

Explanation: Reference Lines: "India's push for using the rupee globally began with its first-ever payment in rupees for crude oil purchased from the UAE."

Difficulty Level: Moderate

- a) The Indian Rupee demonstrates exceptional stability against major currencies for the next decade. This option supports the passage's positive outlook on the Rupee's role in international trade, emphasizing its stability as a key factor for its acceptance. Stability is crucial for a currency's attractiveness in trade as it reduces risks associated with exchange rate fluctuations. If the Rupee maintains stability, it would likely enhance its appeal rather than challenge its acceptance. Therefore, this option would reinforce, not challenge, the author's arguments, making it an incorrect choice.
- b) Countries return to established reserve currencies for trade, valuing convenience and existing deals. This scenario directly challenges the premise that trading in the Rupee (or other domestic currencies) offers significant benefits over traditional reserve currencies like the US dollar or the euro. If countries revert to these established currencies, it could indicate that the perceived advantages of Rupee transactions—such as reduced transaction costs and increased financial independence—are not sufficiently compelling. This return to the status quo would question the viability and future acceptance of the Rupee in global trade, making this option the correct answer.
- c) Rupee Vostro accounts significantly boost India's trade volume with its partners. By facilitating trade and enhancing the Rupee's usability internationally, the success of Rupee Vostro accounts would likely support, not challenge, its global acceptance. This option indicates that the mechanisms put in place to promote the Rupee are effective, leading to increased trade volume and potentially strengthening the currency's international position. Therefore, this outcome would align with the author's arguments in favor of the Rupee's role in international trade, making it an incorrect choice.
- d) Global bodies advocate for domestic currency use in trade, praising the Indian Rupee's model. This statement would further validate the arguments made in the passage, indicating that the push for trading in domestic currencies, exemplified by the Rupee, is gaining international support and recognition. If global financial institutions and trade bodies endorse the model, it would likely bolster the Rupee's acceptance and encourage its use in international transactions. Hence, this option would not challenge but rather support the author's viewpoint, making it an incorrect choice.

96. Answer: B

Explanation: A. India's trade deficit has decreased since the implementation of rupee trade agreements. This statement does not necessarily strengthen the argument regarding the advantages of trading in Indian Rupee. A decrease in trade deficit could be attributed to various factors and may not specifically be linked to rupee trade agreements.



- B. This statement directly supports the main argument of the passage by highlighting one of the advantages of trading in Indian Rupee in international trade its stability against most international currencies. This stability makes the rupee an attractive currency for trade transactions.
- C. The majority of developed countries have already adopted the rupee trade mechanism for their transactions with India.

There is no indication in the passage that the majority of developed countries have adopted the rupee trade mechanism. While some countries, including those in the Gulf region, have expressed interest, the passage does not mention widespread adoption among developed nations.

D. India's Foreign Trade Policy (FTP) amendments have resulted in a significant increase in bilateral trade with partner countries.

Although amendments to the FTP may have facilitated rupee trade, the passage does not provide evidence to support the claim that these amendments have resulted in a significant increase in bilateral trade. The focus of the passage is on the advantages and potential of rupee trade, rather than specific outcomes of FTP amendments.

97. Answer: C

Explanation: Reference Line: "A groundbreaking study has brought to light the significant effects that even short sessions of meditation can have on cognitive skills and decision-making abilities."

Difficulty Level: Moderate

- a) An examination of the procedural methodology used in mindfulness meditation studies. However, the primary content of the passage revolves around the outcomes of such studies rather than the methodologies themselves. The distinction is critical; the passage's emphasis on results, particularly on cognitive skills and decision-making, diverges from a procedural analysis. Hence, Option a) is not the correct answer.
- b) A detailed analysis of the diverse educational backgrounds of meditation study participants. While this option introduces an element of participant diversity into the discussion, it misrepresents the passage's main thrust. The mention of participants' educational backgrounds, if at all present, serves more as a peripheral detail rather than the core subject matter. The focus is on meditation's impact, not the demographic or educational nuances of the study cohort. Therefore, Option b) is not the correct answer.
- c) The impact of short mindfulness meditation sessions on cognitive skills and decision-making. This option directly captures the essence of the passage, which presents findings from a study or studies indicating how brief engagements with mindfulness meditation can significantly affect individuals' cognitive functioning and their ability to make decisions. This summary aligns with the key message intended by the author, making it the most accurate reflection of the passage's content. Hence, Option c) is the correct answer.
- d) The historical development of mindfulness meditation practices and their cultural significance. Although mindfulness meditation indeed has a rich historical and cultural background, this option veers away from the passage's central theme. The focus on historical development and cultural significance would entail a discussion far removed from the empirical findings related to cognitive skills and decision-making abilities highlighted in the passage. As such, this choice does not accurately summarize the primary focus. Therefore, Option d) is not the correct answer.

While personal testimonies can be compelling, they do not constitute the robust empirical evidence that the passage relies on to make its case. The passage references a structured study with a clear methodology and measurable outcomes, which stands in contrast to the less formal nature of anecdotal evidence. This discrepancy indicates that Option b) fails to capture the type of evidence underpinning the author's argument. Hence, Option b) is not the correct answer.
- c) A study involving 60 participants who underwent a brief session of mindfulness meditation before a decision-making task. This option is directly aligned with the passage's narrative, which emphasizes the structured examination of mindfulness meditation's effects through a well-defined participant group and controlled conditions. It's this scientific approach and the findings it yields that form the backbone of the author's argument, making it clear that Option c) accurately reflects the primary piece of evidence. Hence, Option c) is the correct answer.
- d) The theoretical frameworks that support the psychological benefits of long-term meditation practices. While theoretical underpinnings are essential for contextualizing research, the passage focuses more on empirical evidence from specific studies rather than on broad theoretical discussions. This option, therefore, points to a background element rather than the core evidence driving the author's argument about the immediate impacts of short meditation sessions. Consequently, Option d) does not represent the primary evidence. Hence, Option d) is not the correct answer.

Therefore, Option b) is not the correct answer.
- c) A brief mindfulness meditation session enhances the ability to utilize new information under uncertainty. This choice succinctly captures the specific causal relationship highlighted in the passage: engaging in a short session of mindfulness meditation leads to improved cognitive performance, particularly in adapting to new information in uncertain scenarios. This direct linkage between a brief meditation practice and enhanced cognitive ability closely aligns with the study's findings as described, making it the accurate representation of the cause-and-effect relationship. Hence, Option c) is the correct answer.



d) The novelty of meditation study participation leads to a placebo effect that improves cognitive skills. This option introduces an alternative explanation for the observed cognitive improvements, attributing them to a placebo effect rather than the meditation practice itself. However, the passage focuses on the tangible outcomes of actual meditation practice, with no indication that the improvements could be attributed to placebo effects from the novelty of participation. This speculative cause-and-effect relationship is not supported by the passage's content. Hence, Option d) is not the correct answer.

Hence, Option a) is not the correct answer.
- b) The control group engaging in Tangram puzzles showed similar improvements in cognitive skills and decision-making abilities. This option presents a direct challenge to the unique effectiveness of mindfulness meditation by suggesting that similar cognitive enhancements could result from engaging in an entirely different activity. If both activities yield comparable outcomes, it questions the specific contribution of mindfulness meditation to cognitive improvements, directly undermining the argument's basis. This direct comparison effectively weakens the claim about the unique benefits of brief mindfulness sessions. Hence, Option b) is the correct answer.
- c) A larger study replicated the significant cognitive improvements seen in participants after brief meditation sessions. This option is strengthening the study performed on a small group of people. Hence, Option c) is not the correct answer.

Hence, Option c) is the correct answer.

While this option underscores the benefits of long-term mindfulness practice, it does not directly strengthen the specific claim about the impact of brief sessions. Hence, Option c) is not the correct answer.

While the author might acknowledge the existence and contributions of both public and private sectors in healthcare, the focus of the passage is on the challenges and necessities of regulating the private sector to achieve UHC. The statement does not directly contradict the author's main arguments regarding the need for regulation and cost management to ensure accessible and affordable healthcare. Therefore, the author might not specifically disagree with this notion, making Option d) not the correct answer.

This option directly challenges the premise that private healthcare costs are a significant barrier to achieving UHC. If private healthcare costs are not the main factor driving catastrophic health expenditures, then the emphasis on regulating these costs as essential for UHC would indeed be undermined. This directly weakens the argument by challenging its foundational assumption, making Option c) the correct answer.
- d) Surveys demonstrate high patient satisfaction with private healthcare services, correlating with the quality rather than the cost of care. While high patient satisfaction is important, it does not directly address the issue of healthcare affordability or the necessity of cost regulation for achieving UHC. Patient satisfaction can coexist with high costs, and thus, this option does not effectively weaken the argument that cost regulation is crucial for UHC. Hence, Option d) is not the correct answer.

- b) Even with public sector's free care, high out-of-pocket costs arise from the private sector's role. This option effectively captures the paradox described in the passage: the existence of free public healthcare alongside significant costs incurred in the private sector, leading to high out-of-pocket expenditures. This paradox highlights the contrast between the intention of providing free care and the reality of financial burdens from private healthcare, making Option b) the correct answer.
- c) The government's Universal Health Coverage push contrasts with the private sector's resistance to regulation. While this option describes a potential conflict between government objectives and private sector interests, it does not encapsulate a paradox within the healthcare system itself. The focus here is more on the dynamics between different stakeholders rather than a paradoxical situation arising from the system's structure. Hence, Option c) is not the correct answer.
- d) The National Health Policy's universal access goal contrasts with increased costs due to the private sector's growth. This option suggests a contradiction between policy goals and the implications of private sector growth, but it does not directly present a paradox in the way that free public care coexisting with high private costs does. The contrast between goals and outcomes is a common challenge in policy implementation, lacking the paradoxical nature of free care leading to high costs. Hence, Option d) is not the correct answer.

The passage articulates that achieving UHC requires addressing financial barriers, with cost regulation being a critical aspect of this effort. This causal relationship is central to the author's argument, making Option a) the correct answer.
- b) The first emphasizes the benefits of the private healthcare sector; the second discusses government initiatives to supplement public healthcare. While the passage may touch on these topics, this option does not accurately represent the relationship between the bold-faced statements. The focus of the passage is not on the benefits of the private sector or government initiatives in isolation, but rather on how these elements interact within the broader context of achieving UHC. Hence, Option b) is not the correct answer.
- c) The first discusses financial challenges in healthcare; the second offers solutions through public-private partnerships. This option captures elements present within the broader discussion but does not accurately describe the specific relationship outlined by the bold-faced statements. The passage's focus on cost regulation as a means to achieve UHC is not adequately captured by the general discussion of financial challenges and public-private partnerships. Hence, Option c) is not the correct answer.
- d) The first describes the Supreme Court's role in healthcare regulation; the second critiques the government's approach to healthcare cost management. While the passage may mention the Supreme Court and government policies, this option does not accurately reflect the relationship between the bold-faced statements regarding the goal of UHC and the necessity of cost regulation. The emphasis is on the strategic approach to achieving UHC rather than a critique of government policies. Hence, Option d) is not the correct answer.

- c) The challenge of achieving Universal Health Coverage in India, balancing service expansion and financial protection. This option directly reflects the passage's main focus, highlighting the dual challenges of expanding healthcare services to achieve UHC while ensuring that financial protection is maintained. The passage discusses the complexities involved in achieving this balance, making this the most accurate summary of its primary focus. Hence, Option c) is the correct answer.
- d) The benefits and concessions provided to private hospitals, such as land price concessions and exemptions on equipment customs duties. While the passage may mention benefits and concessions to private hospitals as part of the broader narrative, these details are not the central focus. The main discussion revolves around strategies for achieving UHC and managing healthcare costs, rather than on specific benefits provided to private hospitals. Hence, Option d) is not the correct answer.
